Section 2 Severe Weather and School Cancellations

The Superintendent may close public schools in case of severe weather. Representatives of the Superintendent's staff will notify local television and radio stations when school will close due to weather. Notices will be sent via our messaging system ParentSquare. You will automatically receive these notices. School Beacon serves as a backup to ParentSquare. You may sign up for School Beacon at <https://www.schoolbeacon.com/users/login>. Generally, when school is canceled, activities scheduled for that day and evening are also canceled, but some of these decisions are made on a case-by-case basis.

After School Starts. In some instances, closing school during the day is inevitable if children are to safely return home before the brunt of a major storm hits. If school is closed during the day the notice will be communicated by ParentSquare, School Beacon and media. Parents should have a plan in place to accommodate these circumstances.

Parental Decisions. Parents may decide to keep their children at home in inclement weather because of safety concerns. Students absent because of severe weather when school is in session will be marked absent. The absence will be treated like any other absence for legitimate causes provided parents properly notify the school of their decision. Parents may pick up their children in inclement weather during the school day, however, due to safety concerns, students will not be released during an active tornado warning.

Section 3 Supervision Responsibility Before/After School

Arrival at School/Dismissal From School

Students are expected to arrive at school no more than 15 to 20 minutes prior to the first class or school program in which they are participating. Prior to that time, the school is not responsible for supervision of the students. Students will be dismissed at the end of the last period of the school day unless there are other circumstances (early dismissal, detention, etc.). Upon dismissal, students must leave the school grounds and proceed home or to a previously designated location unless participating in a school-sponsored activity. The school is not responsible for supervision of students once the students are to have left school grounds.

Certain days on the calendar are "early dismissal days," meaning that the school day ends earlier than normal. Parents are strongly encouraged to be aware of those days so their children are not left in an unsupervised situation or without the means to get home upon dismissal.

Section 4 Lunch and Breakfast

Breakfast is available each morning, beginning at approximately 7:30 at the high school. A hot lunch is available each day, or a cold lunch can be brought from home. Free or reduced priced breakfasts and lunches are available by applying through the office.

Parents are encouraged to use Powerschool to track lunch accounts and keep them current. Lunch policy permits students to charge certain items if money is in their account. Parents can track student charging through Powerschool.

The Federal School Food Service program regulations forbids any competitive food or beverage service to be in operation one-half hour before the lunch period and one-half hour after this period of time. The same regulation forbids the sale of food or beverage items by other school organizations during the lunch hour. Students are not allowed to order fast food by delivery during the noon hour.

Meal Charge Policy

It is the policy of the District to comply with the National School Lunch Program and School Breakfast Program and all other federal grant programs that provide free or reduced meals to qualifying students.

Student Eligibility

Families of students who may be eligible for free or reduced price school meals should submit an application to determine their eligibility. Applications are available through the Superintendent or Superintendent's designee. As long as an application is submitted on or after July 1, the application will be considered current for the new school year. A student may become eligible for free or reduced meals at any time during the school year if the household experiences a change in financial circumstances.

Meal Account Balances

The District will ensure that families can check their meal account balances in a manner other than exclusively online. The District will ensure that at least one form of meal account payment is free of charge. The District encourages families to pre-pay without charge for free or reduced price meals. Notwithstanding the option to pre-pay, students and families will have a method to add funds during the school day. Any balance remaining in a pre-paid account shall carry over into the next month. Households approved for free or reduced price meals with funds remaining in their meal account at the end of the school year shall receive a refund. When a student leaves the District or graduates, the District shall attempt to contact the student's household to return any funds remaining in the student's meal account. Unpaid meal charges may be carried over at the end of the school year as a delinquent debt and the District shall undertake reasonable collection efforts to collect unpaid meal charges classified as delinquent debt, pursuant to and in compliance with state and federal law. The District shall maintain records of its collection efforts and, once delinquent meal charges are converted to bad debt, its documentation establishing and handling of the bad debt. The district will not use a debt collection agency to collect or attempt to collect, directly or indirectly, debts due or assessed to be for outstanding debts on a school lunch or breakfast account of any student. Nor will the district assess or collect any interest, fees, or other monetary penalties for outstanding debts on a school lunch or breakfast account of any student.

Student Confidentiality

The District will disclose individual student eligibility information only to those persons (and

organizations) who require the information in order to carry out an activity specifically authorized by the National School Lunch Act, subject to applicable legal exceptions. The District shall not use or implement any colored or coded meal cards, tickets, tokens, or other methods of payment that would overtly identify a student as being eligible for free or reduced price meals.

Distribution Annually

This policy shall be provided in writing to all students' households at the start of each school year and to households transferring to the District during the school year. This policy shall also be provided annually to District staff members responsible for the enforcement of this policy, including food service professionals. The Superintendent or the Superintendent's designee shall maintain documentation of the annual distribution of this policy to students' households and District staff.

National School Lunch Program and School Breakfast Program

The District has agreed to participate in the National School Lunch Program and the School Breakfast Program and accepts responsibility for providing free and reduced price meals to eligible children in the schools under its jurisdiction. The District provides the United States Department of Agriculture's required nondiscrimination statement:

Article 1 – School Day

As stated above, all protected bases do not apply to all programs. The first six protected bases of race, color, national origin, age, disability and sex are the six protected bases for all applicants and recipients of the Child Nutrition Programs. The following information will be available in the office of the Superintendent:

- Eligibility criteria for free and reduced meals
- Parent letter and application
- Public release
- Collection procedure

Article 2 – Use of Building and Grounds

Section 1 Visitors

All visitors must report to the office upon entering the main entrance. Scheduled visits to classrooms are encouraged, provided that the visits do not disrupt the educational program, individual students, or create a safety concern. On occasion, the school staff may invite parents to assist with sponsorship of students at school events such as field trips, room parties, etc. Such participation shall be by invitation of the teacher and approved by the building administrators.

Student visits must be of an educational rather than social nature, or include special circumstances, and must be cleared through the office one day in advance.

Section 2 Care of School Property

1. Students are responsible for the proper care of all books, equipment, supplies, and furniture supplied by the school.
2. Students that disfigure property, break windows or do other damage to school property or equipment may be required to pay for the damage done or replace the item.
3. School-issued items that are stolen or damaged from lockers are the responsibility of the student to whom they were issued. Students must pay all fines before they can receive school publications.

Section 3 Lockers, Desks, and Similar School Property

Each student at the Jr.-Sr. High School is assigned a specific locker. Students are on the honor system, as no locks are provided for the lockers, and students should recognize the risk of placing valuables in school lockers. The following guidelines apply to the school lockers:

1. Students assume full responsibility for the items stored in their locker as well as the general physical condition of the locker, including the cleanliness of the locker.
2. If a student chooses to place a lock on his or her locker, the combination or an extra key shall be provided to the office.
3. Only approved beverages are allowed to be stored in the lockers.
4. The school is not liable for lost or stolen items.
5. Random searches of student lockers, desks, and other similar school property provided for use by students may be conducted at the discretion of the administration. Personal property within student lockers or on school grounds are also subject to searches when reasonable cause exists.
6. Any student found tampering, vandalizing, or removing articles from another student's locker will be disciplined by the administration. This may include, but not be limited to, Saturday School, suspension, or expulsion.

Section 4 Search and Seizure

School officials may search a student and student's property with reasonable cause or the student's free and voluntary consent. Vehicles on school property are also subject to search under the same criteria. Areas such as lockers, which are owned and jointly controlled by the district, may be searched if reasonable cause exists to believe that the search will reveal evidence that the student has violated or is violating either the law or school rules. Students shall not keep or maintain any article or material in school-owned lockers, in their personal property, or on their person that is forbidden by district policy or that would lead school officials to reasonably believe that it would cause a substantial disruption on school property or at a school-sponsored function.

Article 2 – Use of Building and Grounds

The following rules apply to searches of students and of a student's personal property and to the seizure of items in a student's possession or control:

1. School officials may conduct a search if there is a reasonable basis to believe that the search will uncover evidence of a crime or a school rule violation. The search is to be conducted in a reasonable manner under the circumstances.
2. Illegal items or other items reasonably determined to be a threat to the safety of others or a threat to educational purposes may be taken and kept by school officials. Any illegal drugs, firearm or other dangerous weapon will be confiscated and delivered to law enforcement officials as soon as practicable.
3. Items which have been or are reasonably expected to be used to disrupt or interfere with the educational process (that is, “nuisance items”) may be removed from student possession.
4. Drug or alcohol tests may be conducted on students based on reasonable suspicion.
5. Drug or alcohol tests may be conducted on a random basis for students participating in extracurricular activities, provided that: a) the student gave consent for testing in advance (attendance at or participation in the extracurricular activity may be withheld in the absence of consent), b) the testing actually be random, c) that the testing procedures limit any intrusion on student privacy, and provide for an appropriate level of confidentiality and accuracy, and d) that the response to positive tests take into consideration student safety and compliance with laws related to reporting and releasing students to law enforcement.

Section 5 Video Surveillance

The Board of Education has authorized the use of video cameras on School District property to ensure the health, welfare and safety of all staff, students and visitors to District property, and to safeguard District facilities and equipment. Notice is hereby given that video surveillance may occur on District property. In the event a video surveillance recording captures a student or other building user violating school policies or rules or local, state or federal laws, the video surveillance recording may be used in appropriate disciplinary proceedings against the student or other building user and may also be provided to law enforcement agencies.

Section 6 Messages and Use of Telephone

Parents should feel free to call the school concerning any matter dealing with their children and the school. Only in urgent situations will students be called from classrooms to answer a telephone call, and only messages from parents will be delivered to students.

The office phone is for school business use. However, students will be allowed to use the phone for school related purposes or a ride home. If a student has to make a non-school related phone call, the office phone will not necessarily be available. If a student is ill and needs to come home, school personnel will make the phone call.

Section 7 Student Valuables

Students, not the school, are responsible for their personal property. Students are cautioned not to bring large amounts of money or items of value to school. If it is necessary to bring valuable items or more money than is needed to pay for lunch, the money or valuables may be left with the school office for temporary safe keeping. Even then, the school is not in a position to guarantee that the student’s property will not be subject to loss, theft, or damage.

Article 3 – Attendance

Section 1 Attendance Policy

Regular and punctual student attendance is required. The administration is responsible for developing further attendance rules and regulations, and all staff are expected to implement this policy and administrative rules and regulations to encourage such regular and punctual student attendance. The District will maintain an accurate record of student attendance.

A. Attendance and Absences.

1. Circumstances of Absences – Definitions. The circumstances for all absences from school will be identified as Excused or Unexcused. Regardless of the type of absence (excused/unexcused), each absence shall count toward the total number of absences for purposes of making up time and/or reporting excessive absences to the county attorney. Absences should be cleared through the Principal's office in advance whenever possible.
 - a. Excused. Any of the following circumstances that lead to an absence will be identified as an Excused absence, provided the required attendance procedures have been followed:
 - (1) Impossible or impracticable barriers outside the control of the parent or child prevent a student from attending school. The parent must provide the school with documentation to demonstrate the absence was beyond the control of the parent or child. This could include, but is not limited to documented illness (including physical or mental illness), court, death of a family member, or suspension.
 - (2) Parent acknowledged absences in which the parent communicated with the school in the prescribed manner that the child is absent and is the parent's responsibility for the extent of the absence. This includes, but is not limited to, illness, vacations, and medical appointments.
 - (3) Other absences as determined by the principal or the principal's designee.
 - b. Unexcused. Absences that are not excused may result in a report to the county attorney and may be classified as follows:
 - (1) Unexcused absences are those in which the parent has not communicated a reason for the student's absence or for which the reason does not qualify the absence as excused.
2. Mandatory Ages of Attendance. A child is of mandatory age if the child will reach age 6 prior to January 1 of the then-current school year and has not reached 18 years of age.

Exceptions for Younger Students. Attendance is not mandatory for a child who has reached the age of 6 years of age prior to January 1 of the then-current school year, but will not reach age 7 prior to January 1 of such school year, if the child's parent or guardian has signed and filed with the school district in which the child resides an affidavit stating either: (1) that the child is participating in an education program that the parent or guardian believes will prepare the child to enter grade one for the following school year; or (2) that the parent or guardian intends for the child to participate in a school which has elected or will elect pursuant to law not to meet accreditation or approval requirements and the parent or guardian intends to provide the Commissioner of Education with a statement pursuant to section 79-1601(3) on or before the child's seventh birthday.

Exceptions for Older Students. Attendance is also not mandatory for a child who: (1) has obtained a high school diploma by meeting statutory graduation requirements; (2) has completed the program of instruction offered by a school which elects pursuant to law not to meet accreditation or approval requirements; or (3) has reached the age of 16 years and has been withdrawn from school in the manner

prescribed by law.

The above information is taken from School Board Policy 5113. A complete version of attendance policies and regulations is published on the school's website and is available upon request at the building offices.

Section 2 Attendance Regulations

The Mead Public Schools will share student attendance information with the Saunders County Attendance Program (ARRIVE). This information may be used by ARRIVE representatives to counsel, encourage and/or otherwise take actions to encourage regular attendance in school.

- 1) Any child between the ages of 6 and 18 shall attend school each day that school is in session; except, when excused by school authorities. The administration shall determine if an absence is excused or unexcused. Parents or guardians must notify the school by phone, writing, or email regarding any absence other than absences for school activities. If notification is not provided within two days of the absence, the absence may be considered unexcused. Students that return during the school day must report to the office to check in and receive an admit to class slip.
- 2) Each teacher will record attendance of all students each class period checking for students being absent or tardy.
- 3) Students absent from class are responsible to make up any work missed. This should be done before the absence, if possible. Clarification of makeup procedures may be identified in the student handbook.
- 4) Following a student's 5th absence in a semester, the parents of that student will be notified of the attendance policy and the consequences of additional absences.
- 5) Following a student's 8th absence in any one class period in a semester, the student's attendance record shall be reviewed by the building attendance committee. The attendance committee shall determine provisions for making up time for each of the absences that exceed 8 in a semester. Failure to complete the provisions enacted by the attendance committee will result in the denial of credit earned in any class where the absences have not been made up.

In the event special circumstances exist (examples include but are not limited to chronic illness as documented by a medical professional, hospitalization, surgical, injury or accident recuperation), the attendance committee may waive attendance make up provisions for up to 15 days in one semester but not more than 20 days in a school year. If a student reaches 15 days of absence in a semester or more than 20 days in a year and is unwilling or unable to complete the makeup provisions enacted by the attendance committee, that student's credit will be withheld in each class that has reached this level of absences. Any student who is denied credit may appeal the decision to the board of education by requesting an appeal at the next regular or special meeting of the board.

- 6) Students who accumulate five (5) unexcused absences in a quarter shall be deemed to have "excessive absences". Such absences shall be determined on a per day basis for elementary students and on a per class basis for secondary students. When a student has excessive absences, the student will be considered truant and Policy 5008 will be applied.
- 7) Students who accumulate ten (10) absences per semester or twenty (20) absences per school year shall be deemed to be habitually truant and Policy 5008 will be applied, and the principal shall file a report with the county attorney of the county in which the student resides.
- 8) A student must be in attendance the full day of the scheduled extracurricular event in which the student is a participant, unless the school is notified of extenuating circumstances and the student is excused by the school administration. Illness is not an extenuating circumstance.
- 9) Students and parents are expected to make medical, dental and other personal appointments outside the school day whenever possible.
- 10) Appeals to the attendance policy may be made in writing or by appearance to the Board of Education.

Article 3 – Attendance

Section 3 Sign Out Procedures

Students are required to remain on campus from the time they arrive in the morning until they are dismissed in the afternoon. Students leaving school for any reason must have parental/guardian permission. Parental permission can be written or verbal notification from the parent to the office prior to the student's departure. If a student leaves the school for any reason, including illness, they must sign out in the office. Students who do not sign out are subject to disciplinary action. Upon returning to school that same day, students are expected to sign in at the office.

If there is a special circumstance, such as a court order limiting access to a student by a parent or guardian, affecting who a student can be released to, the parent must inform the Principal and provide the Principal with a copy of that order to maintain on file at the school.

Section 4 Absence Procedures

A student's absence from school, for any reason, should be communicated to the school as soon as possible. Someone will be on duty from approximately 7:45 a.m. to 3:45 p.m. each school day to receive telephone calls regarding absences, or a message can be left on the answering machine outside of office hours. The high school number is 624-3435 and the elementary number is 624-6465. Attendance information may also be emailed to jmiller@meadpublicschools.org or aschaal@meadpublicschools.org

The same procedure applies if it is necessary to leave the school during the day. Valid notification by parent or guardian must be provided to the office prior to being released from school. Students who leave school and then ask parents to call later may be recorded as unexcused.

Absences must be excused or verified within two days of the occurrence. Absences which have not been excused or verified within two days will be considered trancies or unexcused absences. It is the students' responsibility to have absences verified by the home. **All absences, except those for school activities, count toward the absence limits.**

Students who are truant from school may be required to be accompanied by a parent to regain entrance to the school setting. Students who are truant from school two or more times may be excluded from school for excessive truancy.

Medical Appointments. Medical appointments are considered excused absences. However, students are expected to attend school until a reasonable time when appropriate and/or return in a timely manner. Failure to do so may cause portions of the absence to be considered unexcused.

Oversleeping. Oversleeping is not considered an excused absence. Thus, it is important to report to school as soon as possible in the case of oversleeping. Students absent for one period are considered ineligible for extracurricular activities, including practice, the day of the absence.

Tardy to School. Students will be considered tardy to school if they are not seated in their assigned class or ready and attentive in their assigned area when the bell for their first class rings. While car trouble may occasionally occur, reports of car trouble should be made early enough to indicate that the student would have arrived on time. Students with repeated reports of car trouble will be required to make up the time missed. Students who arrive late are required to sign in at the office to receive an admittance pass. A student who is tardy to school will receive the following sanctions:

Tardies 1-3: Warning

Tardies 4-10: Lunch Detention.

More than 10 tardies in a semester may result in 60-minute detentions or assignment to Saturday School or other consequences.

Tardy to Class. Students will be considered tardy to class if they are not in their assigned classroom when the tardy bell rings, unless they have a pass from the teacher who detained them. Specific tardy guidelines once students are in the classroom are at the discretion of the classroom teacher.

Section 5 Attendance Committee

If a student reaches an excessive number of absences, a meeting of the Attendance Committee shall be held. The Attendance Committee will consist of teachers and Principal. The purpose of the Attendance Committee is to examine extenuating circumstances surrounding absences. The Committee may ask the student to make up absences by attending Saturday Adjustment Class, staying after school, or remaining in school instead of attending some extra-curricular events. The Committee will then make a recommendation to the Board of Education concerning the granting or denial of credits, or referral to the Saunders County Attendance Program. The Board of Education has final authority to grant or deny credits.

Section 6 Make-up Work

The student has the responsibility to contact teachers regarding make-up assignments. As a general guideline for each excused absence, ~~two school days~~ the number of days missed plus one additional day will be allowed to make up the daily work ~~for each day~~ missed during the absence. If requested in a timely manner, assignment sheets will be prepared for students who are ill.

Make-up Work Guidelines

The make-up work of students will be counted for course credit when satisfactorily completed according to the guidelines stated below, or such other guidelines as approved by the Superintendent or the Superintendent's designee.

A) Excused Absences

1) To receive credit for work missed due to excused absences, the student should make every reasonable effort to have make-up work completed before he/she leaves, turn it in on time, or make arrangements with the teachers involved. School sponsored activities will not be counted as absences, but students must complete the School Activity Absence Form prior to departure.

2) To receive credit for unexpected or unusual absences, such as illness or funerals, valid notification must be on file in the Principal's office. Students will get assignments from teachers, and the teachers involved will determine the due date to get make-up work completed and turned in.

B) Unexcused Absences

1) To receive credit for unexcused absences, (e.g. truancy, class skipping, any absence not deemed to be excused), the student may be assigned appropriate make-up work at a teacher assigned time. (For example, before or after school, during noon, or other times that the teacher is available to assist students.) The student may be denied credit.

C) In-School Suspension.

1) To receive credit for absences due to in-school suspension, the student will complete the assignments assigned by the teacher(s). The student will not be considered absent for the day. The student will receive full credit for work completed on time.

D) Out-Of-School Suspension

- 1) Students who are under out-of-school suspension will be provided the opportunity to complete daily classroom work as well as examinations.
- 2) Students who have been suspended should have as much daily classroom work completed upon return to school as possible. Teachers will determine what work could have been completed. Students will be given the day they return to school after a short-term suspension to complete all examination work.
- 3) Students will make arrangements with teachers to complete examination work after a long-term suspension.
- 4) Students will receive full credit for work they have completed during the suspension, as long as it is completed within the outlined time above.
- 5) It will be the student's responsibility to get all daily classroom work assignments as well as to make examination arrangements during the time of suspension. These arrangements are to be made prior to the start of or at the conclusion of the regular school day, and will not be made during the regular school day.

E) Students Expelled From School

Students expelled from school will receive no credit for the time they are removed from the school.

Section 7 Attendance is Required to Participate in Extracurricular Activities

Students must attend school the entire day of any scheduled, extracurricular school activity in order to participate in the activity. This includes but is not limited to performances, games, practices, and dances. Failure to attend will result in a student being withheld from participation in the activity. Any student missing more than 20 minutes of a period will be marked as absent and will not be considered to have attended the entire day.

The Principal or the Principal's designee retains the authority to grant participation should exceptional circumstances exist. Participation will normally be granted only when the absence cannot be avoided, is of a medical nature, or has been pre-arranged and the student has made academic arrangements for all classes. Students absent for a medical/doctor appointment shall provide a note from the medical provider. Students should attend the periods before and after a medical/doctor appointment whenever possible. Permission to participate will not be granted in cases of illness or oversleeping.

Article 4 – Scholastic Achievement

Section 1 Grading System

Students will receive percent and letter grades on report cards and letter grades on transcripts. The following scale will be used:

Teachers will define the grading procedures to be used in their classes.

Class Rank Scholastic class rank is calculated at the end of each semester for each student in the high school. Grades in all high school classes, except music/PE, are figured into a student's high school cumulative grade point average (GPA). Music/PE classes count for credit hours for graduation, but they are not figured into the cumulative GPA. The student's final class standing and grade point average is very important in consideration of each individual as a requirement for college entrance and scholarship application.

Section 2 Registration Requirements

Students are required to be enrolled in six academic classes during the school day. Only one study hall is permitted, unless extenuating circumstances exist. Only in the most extreme cases will students be allowed to enroll in fewer than six courses. For obvious reasons, work release students are exempt.

On-line Courses

Students are encouraged to register for and complete on-line courses for college credit if their schedule permits. However, when an on-line course lasts only one quarter of the Mead academic calendar, students will be required to register for a second on-line course during the remaining quarter or complete coursework via another method such as SchoolsPLP.

Section 3 Graduation Requirements

To participate in commencement exercises, a student must fully complete all requirements for graduation prior to the deadline established by the administration. Such students are still able to complete the requirements at a later date and earn a Mead Public Schools diploma. Students who have not completed graduation requirements by the established deadlines will not participate in Senior Sneak.

To be eligible for graduation from Mead High School, a student must have earned a minimum of 240 semester hours credit in grades 9 through 12 inclusive. Credit hours will be computed in accordance with the Nebraska Department of Education.

In an effort to assure that graduates of Mead High are adequately prepared for today's society, the following graduation requirements have been established.

<u>English</u>	40 credit hours (30 hours required in English 1, English 2, & English 3)
<u>Speech</u>	5 credit hours
<u>Math</u>	30 credit hours (10 hours required in both Algebra I and Geometry)
<u>Science</u>	30 credit hours (10 hours required in both physical science and biology).
<u>S. Studies</u>	30 credit hours (10 hours required in both American History and American Govt.)
<u>Health</u>	5 credit hours
<u>PE</u>	10 credit hours in physical education

Computer

Applications 5 credit hours

Financial 5 credit hours (can come from Consumer Math, Personal Finance, or an approved dual credit financial literacy course in grades 10-12)

Electives 80 credit hours

In addition, each student shall also complete and submit a Free Application for Federal Student Aid prior to graduation, unless the required opt-out form is completed by either: (1) the student's parent or legal guardian; (2) the Principal, if the Principal determines that good cause exists not to require the student to complete the FAFSA; or (3) an emancipated student or student of at least 19 years of age.

Section 4 Promotion and Retention

Students will be placed at the grade level and in the courses best suited to them academically, socially and emotionally as determined by the professional staff. Students will typically progress annually from grade to grade. However, a student may be retained at a grade level when such is determined in the judgment of the professional staff to be appropriate for the educational interests of the student and the educational program. A student will be required to repeat a course in which he/she earned a failing grade. Failure to meet the attendance requirements can also result in denial of credit for a course or retention in a grade.

If a parent or guardian would like their student to retake a grade level, the parent or guardian must meet with the Superintendent or designee to discuss the student repeating a grade. At that meeting, the parent or guardian must provide evidence of academic needs, illness, or excessive absenteeism that would warrant the student to repeat the grade. A student in kindergarten through fourth grade may be retained due to academic needs, illness, or excessive absenteeism. A student in grades fifth through twelfth grade may be retained due to excessive absenteeism. At such meeting, the Superintendent or designee shall identify any alternative educational opportunities, including remedial instruction, if applicable, and verify any special education supports available to such student. If the student's parent or guardian still intends for their student to repeat a grade, such parent or guardian shall then complete the required form and return such form to the District. Upon completion of the form and if all requirements pursuant to this policy and law are met, the District shall permit the student to repeat the student's grade for the next school year.

In Junior High School (grades 7 & 8), students must take classes equal to 120 hours of credit. Of these 120 hours, the student must pass and receive 100 hours of credit to include 60 hours of credit in English, Math, Science and Social Studies. A junior high student may be retained if he or she fails to receive 30 hours of credit in the combined areas of English, Math, Science and Social Studies each year.

Section 5 Weekly Eligibility and Midterm Reports

At the beginning of each week a list of students who are failing classes will be compiled. Students listed will not be able to leave study hall unless they have a pass from another teacher to see them or go to the library for specific work on an assignment. They are to be confined to the study hall for the remainder of the week. Junior high and senior high school students involved in activities must be passing 25 credit hours to be eligible for participation in competitions or performances. It will be indicated on the weekly report if the students are ineligible to compete in the activity that they are involved in. This does not affect practice. Students declared ineligible remain so for the remainder of the week. Midterm grades will be sent home in the middle of each quarter.

Article 4 – Scholastic Achievement

Section 6 Report Cards

Report cards are issued at the end of each quarter. Percentage and letter grades are used to designate a student's progress. A grade of "F" (failing) carries no credit. A grade of "I" (incomplete) received at the end of a grading period must be made up within two weeks, unless the Principal determines that circumstances necessitate extended time. At the end of the allotted time, missing assignments will receive grades of "0" and those grades will be averaged into the final grade. An Incomplete may also be declared if a student fails to complete the checkout procedures for a class. Failure to complete the checkout process within two weeks may result in an Incomplete for those classes.

Section 7 Honor Roll

The purpose of the Honor Roll is to recognize those students who demonstrate academic excellence. Honor rolls will be determined on a quarterly and semester basis. Students will be recognized accordingly:

1. A Honor Roll: A's (93% or above) in all classes
2. B Honor Roll: A's or B's (no grade lower than 85%) in all classes

Section 8 Academic Integrity

1. **Policy Statement:** Students are expected to abide by the standards of academic integrity established by their teachers and school administration. Standards of academic integrity are established in order for students to learn as much as possible from instruction, for students to be given grades which accurately reflect the student's level of learning and progress, to provide a level playing field for all students, and to develop appropriate values. Cheating and plagiarism violate the standards of academic integrity. Sanctions will be imposed against students who engage in such conduct.
2. **Definitions:** The following definitions provide a guide to the standards of academic integrity:
 - (a) **"Cheating"** means intentionally misrepresenting the source, nature, or other conditions of academic work so as to accrue undeserved credit, or to cooperate with someone else in such misrepresentation. Such misrepresentations may, but need not necessarily, involve the work of others. Cheating includes, but is not limited to:
 - (1) **Tests** (includes tests, quizzes and other examinations or academic performances):
 - (i) **Advance Information:** Obtaining, reviewing or sharing copies of tests or information about a test before these are distributed for student use by the instructor. For example, a student engages in cheating if, after having taken a test, the student informs other students in a later section of the questions that appear on the test.
 - (ii) **Use of Unauthorized Materials:** Using notes, textbooks, pre-programmed formulae in calculators, or other unauthorized material, devices or information while taking a test except as expressly permitted. For example, except for "open book" tests, a student engages in cheating if the student looks at personal notes or the textbook during the test.
 - (iii) **Use of Other Student Answers:** Copying or looking at another student's answers or work, or sharing answers or work with another student, when taking a test, except as expressly permitted. For example, a student engages in cheating if the student looks at another student's paper during a test. A student also engages in cheating if the student tells another student answers during a test or while exiting the testing room, or knowingly allows another student to look at the student's answers on the test paper.
 - (iv) **Use of Other Student to Take Test.** Having another person take one's place for a

test, or taking a test for another student, without the specific knowledge and permission of the instructor.

- (v) **Misrepresenting Need to Delay Test.** Presenting false or incomplete information in order to postpone or avoid the taking of a test. For example, a student engages in cheating if the student misses class on the day of a test, claiming to be sick, when the student's real reason for missing class was because the student was not prepared for the test.
 - (2) **Papers** (includes papers, essays, lab projects, and other similar academic work):
 - (i) **Use of Another's Paper:** Copying another student's paper, using a paper from an essay writing service, or allowing another student to copy a paper, without the specific knowledge and permission of the instructor.
 - (ii) **Re-use of One's Own Papers:** Using a substantial portion of a piece of work previously submitted for another course or program to meet the requirements of the present course or program without notifying the instructor to whom the work is presented.
 - (iii) **Assistance from Others:** Having another person assist with the paper to such an extent that the work does not truly reflect the student's work. For example, a student engages in cheating if the student has a draft essay reviewed by the student's parent or sibling, and the essay is substantially re-written by the student's parent or sibling. Assistance from home is encouraged, but the work must remain the student's.
 - (iv) **Failure to Contribute to Group Projects.** Accepting credit for a group project in which the student failed to contribute a fair share of the work.
 - (v) **Misrepresenting Need to Delay Paper.** Presenting false or incomplete information in order to postpone or avoid turning in a paper when due. For example, a student engages in cheating if the student misses class on the day a paper is due, claiming to be sick, when the student's real reason for missing class was because the student had not finished the paper.
 - (3) **Alteration of Assigned Grades.** Any unauthorized alteration of assigned grades by a student in the teacher's grade book or the school records is a serious form of cheating.
 - (b) **"Plagiarism"** means to take and present as one's own a material portion of the ideas or words of another or to present as one's own an idea or work derived from an existing source without full and proper credit to the source of the ideas, words, or works. Plagiarism includes, but is not limited to:
 - (1) **Failure to Credit Sources:** Copying work (words, sentences, and paragraphs or illustrations or models) directly from the work of another without proper credit. Academic work frequently involves use of outside sources. To avoid plagiarism, the student must either place the work in quotations or give a citation to the outside source.
 - (2) **Falsely Presenting Work as One's Own:** Presenting work prepared by another individual or computer software/program (Artificial Intelligence) in final or draft form as one's own without citing the source, such as the use of purchased research papers or use of another student's paper.
 - (c) **"Contributing"** to academic integrity violations means to participate in or assist another in cheating or plagiarism. It includes but is not limited to allowing another student to look at your test answers, to copy your papers or lab projects, and to fail to report a known act of cheating or plagiarism to the instructor or administration.
3. **Sanctions:** The following sanctions may occur when a student engages in cheating, plagiarism,

or contributing to an academic integrity offense:

- (a) Academic Sanction. The instructor may refuse to accept the student's work in which the academic integrity offense took place, assign a grade of "F" or zero for the work, and may require the student to complete a test or project in place of the work within such time and under such conditions as the instructor may determine appropriate. In the event the student completes the replacement test or project at a level meeting minimum performance standards, the instructor will assign a grade which the instructor determines to be appropriate for the work.
- (b) Report to Parents and Administration. The instructor will notify the Principal of the offense and the instructor or Principal will notify the student's parents or guardian.
- (c) Student Discipline Sanctions. Academic integrity offenses are a violation of school rules. The Principal may recommend sanctions in addition to those assigned by the instructor, up to and including suspension or expulsion. Such additional sanctions will be given strong consideration where a student has engaged in serious or repeated academic integrity offense or other rule violations, and where the academic sanction is otherwise not a sufficient remedy, such as for offenses involving altering assigned grades or contributing to academic integrity violations.

Article 5 – Support Services

Section 1 Special Education Services

Special education means specially designed instruction and related services adapted as appropriate to the needs of an eligible student with a disability. Special education is provided at no cost to the parent to meet the unique needs of a child with a disability. A student verified as having autism, behavior disorders, deaf-blindness, developmental delay, hearing impairments, mental handicaps, multiple disabilities, orthopedic impairments, other health impairments, specific learning disabilities, speech-language impairments, traumatic brain injury or visual impairments, who because of these impairments needs special education and related services. Referrals are made by teachers or parents to a Student Assistance Team. If the student assistance team or comparable problem solving team feels that all viable alternatives have been explored, a referral for multidisciplinary evaluation is completed. An evaluation is conducted to assist in the determination of whether a student has a disability and the nature and extent of the special education and related services the student needs. The evaluation is conducted only with written consent of a parent or guardian. A multidisciplinary evaluation team (MDT) will then meet to determine whether the student is eligible for special education.

Section 2 Guidance Services

Mead Public Schools employs counselor(s) for the purpose of assisting with the District's testing program, to assist with scheduling and for students to discuss problems and resolve conflicts. If students wish to see a counselor, they should contact the counselor's office and make arrangements for an appointment. The Guidance Counselor will meet with students at least once during the school year, and more often when appropriate.

Each year, the guidance department will be giving various batteries of tests to measure interest, achievement, aptitude and academic potential. The guidance department will also help students analyze their own potential and assist them with pre and post interpretation of tests that are administered. Test results will become a part of the student's cumulative record, and will be available to the student and parent for consultation purposes. Dates of these tests will be published through student and staff bulletins.

Section 3 Homework Academy

The intent of Homework Academy is to encourage students to complete assignments in a timely manner and avoid receiving zeroes.

- Students who fail to hand in an assignment or hand in an incomplete assignment will be assigned to Homework Academy the day after the assignment was due.
- Homework Academy will be assigned from 3:30 to 4:00 the day after the work should have been turned in. It will be held in the Library or in classrooms.
- Students are reminded of their Homework Academy assignment 8th period of the day they are to serve.
- Students who fail to make up quizzes or tests may be assigned to Homework Academy at the teacher's discretion.
- Students with missing assignments will be submitted to the office.
- Students will be responsible for notifying parents if they need transportation or will arrive home late. Bus students are NOT exempt from this policy.
- Students may be excused from Homework Academy if the missing assignment is turned in to the appropriate teacher prior to the assigned Homework Academy date and appears to be satisfactorily completed.

Article 5 – Support Services

- If the missing assignment is completed during Homework Academy and handed in, the student will be dismissed from Homework Academy early, if the assignment appears to be completed in a satisfactory manner.
- Students who do not attend Homework Academy will be assigned to 60 minutes of makeup time the next day and will be informed of this by the Principal or the Principal's designee.
- Repeated failures to attend or failures to attend makeup time will result in Saturday Schools or other consequences.
- Students who fail to attend an assigned Homework Academy will not be eligible for extracurricular practices until the assignment is completed and turned in AND make up time is served.
- Athletes and other extracurricular participants may be subject to consequences for being late to their activity.
- At the discretion of the classroom teacher, the final grade for late assignments will be reduced by 10% per day.
- As a general guideline, teachers may assign students to Homework Academy for two days per assignment. Assignments not completed by that time may be recorded as zeroes.

Section 4 College Visits

To be eligible for college visitations, seniors should have taken entrance exams (ACT or SAT), and/or must have demonstrated a sincere desire to attend college with the counselor. Juniors must have administrative / counselor approval to be excused for college visitations. NOTE: These days DO count against the student's attendance. However, college visitation absences may be waived if pre-approved by the guidance counselor/office.

Section 5 Scholarships

Seniors are eligible for scholarships that are offered by colleges, universities, trade and technical schools, and local organizations. Watch for information in the announcements. The counselor can provide more information about scholarships, such as entrance requirements and applications.

Section 6 Transcripts

Transcripts are accepted from all authorized schools. Transcripts are forwarded to other Junior and Senior High Schools when necessary. Upon request, all records can be sent to any institution of higher learning or a prospective employer. Any student wishing to inquire about these records should contact the Guidance Counselor's office or the Principal's office. A release form must be on file in the student's cumulative folder before a transcript will be released at the request of a third party.

Section 7 Work Release Program

Juniors and seniors who are on track to graduate and passing ALL classes and wish to seek employment may apply to leave school early during first semester as well as second semester (usually the last period or two of the day) for employment purposes. Any classes that are dropped during the middle of a semester would result in loss of those credit hours. Other guidelines exist. Apply with the guidance counselor.

Section 8 Withdrawal from School

When a student withdraws from school, he/she must report to the Counselor's office. The student must complete the Student Drop Slip before official confirmation can be made.

Section 9 Change of Residence

Changes of address or contact information should be reported to the office as soon as possible. Students who move to another city or transfer to another school, must obtain a withdrawal form from the office. This form must be signed by the student's teachers, counselor, the librarian, and the office. All textbooks and other materials belonging to the school must be checked in before you will be given a transfer slip for admission to the new school. Records will be sent to the new school upon request of that school.

Section 10 Health Services and Guidelines

Student Illnesses

School health personnel will notify parents when a student needs to be sent home from school due to illness. Conditions requiring a student be sent home include: Temperature of or greater than 100°F., vomiting, diarrhea, unexplained rashes, live head lice, nits, or determination by the school that the child's condition prevents meaningful participation in the educational program, presents a health risk to the child or others, or that medical consultation is warranted unless the condition resolves. Students should be fever-free for 24 hours without the aid of fever-reducing medicines before attending school.

Guidelines for Administering Medication

Whenever possible, students should be provided medications outside of school hours. In the event it is necessary that a student take or have medication available at school, the parents/guardians must provide a signed written consent for the student to be given medication at school. A consent form is available at the school health office. If the student has asthma or diabetes and is capable of self-managing his or her health condition, parents should contact the office to develop a self-management plan.

Medications must be provided to the school by the parent/guardian in the pharmacy-labeled or manufacturer-labeled bottle. Repackaged medications will not be accepted.

Physical and Visual Examination

Evidence of a physical examination and a visual evaluation is required within six months prior to entrance into kindergarten and, in the case of transfer from out of state, to any other grade. A physical examination is also required prior to entrance into the seventh grade. Students participating in athletics must also have a physical. The physical examination is to be completed by a physician, a physician's assistant, or an advanced practice registered nurse; the visual evaluation is to be completed by any of the foregoing or an optometrist. A parent or guardian who objects to the physical examination and/or visual evaluation may submit a written statement of refusal for his or her child. Waiver forms are available.

Immunizations

Students must show proof of immunization. A student who does not comply with the immunization requirements will not be permitted to continue in school. Students with medical conditions or sincerely held religious beliefs which do not allow immunizations must complete a waiver statement or affidavit. Unimmunized students may be excluded from school in the event of a disease outbreak.

Communicable Diseases

Students with a communicable disease at the stage where it may be contagious to others should not be in school. The following signs and symptoms should be looked on with suspicion before sending him/her back to school: flushed face, sore throat, inflamed eyes, nasal discharge, cough, headache, earache, nausea and vomiting, diarrhea, rash, body aches. The following table includes some but not all communicable diseases and exclusion procedures noted by the Nebraska Department of Health and Human Services:

DISEASE EXCLUSION FROM SCHOOL

Chicken Pox	May return to school after all lesions are crusted.
Diphtheria & Pertussis	Must have documented physician approval to return to school.
Fifth Disease	May return to school after fever and malaise are gone. May return with rash.
Hand, Foot & Mouth	May return to school after acute phase and fever-free for 24 hours without medication.
Influenza	Excluded for duration of illness and until fever-free for 24 hours without medication.
German Measles (Rubella)	Exclude for duration of illness and for a minimum of 4 days after onset of rash.
Measles (Rubeola)	Exclude for duration of illness and for a minimum of 4 days after onset of rash.
Mumps	Exclude for 5 days from onset of swelling in the neck.
Pinkeye	May return when eye is normal in appearance or with physician approval.
Pinworm	May return after documented treatment by physician.
Strep Infection	May return when fever-free and under treatment for 24 hours.

SKIN AND SCALP CONDITIONS

Head Lice	Excluded upon recognition of active infestation. May return after treatment and removal of nits.
Impetigo	May return after treatment and acute symptoms resolved.
Ringworm	If affected areas cannot be covered with clothing/dressing, exclude until treatment started.
Scabies	May return the day after treatment is started.

Birth Certificate Requirements

State law requires that a certified copy of a student's birth certificate be provided within 30 days of enrollment of a student in school for the first time. A certified copy may be obtained from the Bureau of Vital Statistics in the state in which the child was born. Assistance in obtaining birth certificates may be obtained from Health Records Management, P.O. Box 95065, Lincoln, NE 68509-5065. There is a fee per certificate.

Please note: The document parents receive from the hospital looks like a birth certificate, but it is not a certified copy. A certified copy has the raised seal of the state of Nebraska on it and is signed by the director of vital statistics. If a birth certificate is unavailable, other reliable proof of a student's identity may be used. These documents could include naturalization or immigration documents showing date of birth or official hospital birth records, a passport, or a translation of a birth certificate from another country. The documents must be accompanied by an affidavit explaining the inability to produce a copy of the birth certificate.

Section 11 Transportation Services

Transportation to and from school is provided to students in accordance with law and Board policy. Students may also be transported on field trips and when participating in school activities. Students are expected to follow the behavioral expectations for riding school buses. Students, other than those

regularly assigned to a specific bus, will not be allowed to ride the bus after school unless permission is obtained from the administration. Permission may be obtained if prior written or verbal notification is provided to the office by the parents of the involved students. The buses will not leave their normal route to pick up or drop off students.

Behavior on School Buses

- I. **General Conduct Rules Apply:** While riding school buses, students are expected to follow the same student conduct rules which apply while on school property or attending school activities, functions or events. There are also special conduct rules for riding school buses. These rules also apply to riding other school vehicles.
 - II. **Special Conduct Rules for Riding School Buses.**
 - A. Rules for Getting On and Off the Bus
 1. Be on time to be picked up. As a general rule, get to the bus stop before the scheduled pick up time. Students who miss the bus should notify parents.
 2. While waiting for the bus, stay at least 5 feet away from the street, road or highway. Wait until the bus comes to a complete stop before approaching the bus.
 3. Exit the bus only at the approved destination (your school or your approved bus stop). Exit the bus as directed by the driver. Do not run.
 4. If it is necessary to cross the street after exiting the bus, cross in front of the bus where the driver can see. Wait for the driver to signal, before crossing the street.
 - B. Rules on the Bus
 1. Be respectful of the bus driver. Immediately follow all directions of the driver or other staff member on the bus.
 2. Sit in the seat facing forward and remain seated at all times. Use seat belts in vehicles in which they are available.
 3. Talk quietly and use appropriate language. There is to be complete silence at railroad crossings.
 4. Keep all parts of your body and all objects inside the bus.
 5. Keep hands, arms, legs and belongings to yourself.
 6. No fighting, harassment, bullying, intimidation or horseplay.
 7. Do not throw any object.
 8. Do not bring any weapon (real or imitation) or dangerous objects on the school bus.
 9. Do not damage the school bus.
 - III. **Getting the Driver's Assistance:** If a student needs assistance from the driver, he/she should wait until the bus is at a full stop. If he/she is close enough, tell the driver what is needed. Students too far away for the driver to hear should ask a student in front of them to get the driver's attention. If necessary, walk up to the driver, while the bus is at a full stop. If immediate assistance is needed for an emergency, take all action needed to safely get the help of the driver.
- Consequences for Rule Violations:** Consequences for school bus misconduct may include loss of school privileges, restriction or suspension of bus privileges, and other disciplinary measures, up to and including expulsion from school.

Section 12 Complaint Procedures

The proper procedure for a parent or student to make complaints or raise concerns is to begin with the school employee who is most immediately or directly involved in the matter, as illustrated in the complaint procedure set forth below. There are specific procedures to address certain complaints or

concerns, such as discrimination or harassment, bullying, disciplinary actions. Those procedures should be used where applicable.

1. Complaint procedure

- Step 1. Schedule a conference with the staff person most immediately or directly involved in the matter.
- Step 2. Address the concern to the Principal if the matter is not resolved at Step 1.
- Step 3. Address the concern to the Superintendent if the matter is not resolved at Step 2.
- Step 4. Address the concern to the Board of Education if the matter is not resolved at Step 3.

2. Conditions Applicable to All Levels of Complaint Procedure

All information to be considered at each step should be placed in writing in order to be most effective. Action or decisions will be expedited as quickly as possible, typically within ten (10) calendar days, depending on the nature of the complaint and the need for prompt resolution.

Article 6 – Drug Free Schools

Section 1 Drug-Free Schools.

The District implements regulations and practices which will ensure compliance with the federal Safe and Drug-Free Schools and Communities Act and all regulations and rules promulgated pursuant thereto. The District's safe and drug-free schools program is established in accordance with principles of effectiveness as required by law to respond to such harmful effects. The consistent message of the program is that the improper use or possession of prescription drugs, use or possession of illicit drugs, and the unlawful possession and use of alcohol and tobacco is wrong and harmful. The appropriate sections of District Policy 5131.7: Provision for a Drug Free Workplace/School follow this statement.

5131.7 PROVISION FOR DRUG FREE WORKPLACE/SCHOOL

Philosophy

Mead Public Schools is committed to providing an environment that is safe and provides appropriate motivation and support to ensure a creative and productive student body and work force. To this end, the District unequivocally endorses the philosophy that the school and workplace should be free from the detrimental effects of drugs and alcohol.

Standards of Conduct

It is unlawful and, therefore, absolutely prohibited for any student or employee of the District to:

1. Possess any controlled substance, or possess that which is prohibited by law,
2. Possess any prescription drug in an unlawful fashion,
3. Possess alcohol on school premises or as a part of any of the school related activities,
4. Use any illicit drug,
5. Distribute any illicit drug,
6. Use any drug in an unlawful fashion,
7. Distribute a drug or controlled substance when such distribution is unlawful,
8. Possess, use or distribute alcohol,
9. Possess, distribute or use illegal tobacco products, including vapor products (such as e-cigarettes), alternative nicotine products, tobacco product look-alikes, and products intended to replicate tobacco products either by appearance or effect.

Definitions

As used in this policy, prohibition against the unlawful possession, use, or distribution of drugs, alcohol and tobacco on school premises or as a part of any of the school related activities shall mean, but not be limited to the following:

1. The possession, use or distribution of any substance which is declared by the State of Nebraska or any other applicable law to be an illicit or illegal substance.
2. The possession, use, or distribution of alcohol on school premises or as a part of any of the school related activities.
3. The possession, use, or distribution of tobacco products, including vapor products (such as e-cigarettes), alternative nicotine products, tobacco product look-alikes, and products intended to replicate tobacco products either by appearance or effect.

As used herein, the term "school premises" shall mean any location whether owned, leased, or in other manner under the control of the Board of Education of the District, or any location where school related activities occur. As used herein, the phrase "as a part of any of the school related activities" shall mean any activity or enterprise carried out in whole or in part under the auspices of the district, or which a reasonable person would consider school related.

Article 6 – Drug Free Schools

Procedures

1. All students, their parents, all school employees and each new employee will receive a copy of this policy.
2.
 - a. 2a. refers to employees and is therefore included in the employee handbook.
 - b. Each student and their parents will acknowledge receipt of this policy and will sign such form acknowledging receipt and acknowledging the District's policy of absolutely prohibiting conduct as set forth in this policy, and further acknowledging that disciplinary sanctions can and will be consistently enforced up to and including expulsion from school and referral for prosecution for any failure to comply with the stated standards of conduct and further acknowledging that such compliance is mandatory, and further acknowledging that this policy is adopted pursuant to P.L. 101-226, 34 C.F.R., Part 86, other applicable statutes, and will further acknowledge that failure to comply with such federal requirements may put the district's receipt of federal funds in jeopardy. This policy will be included in the student handbook and acknowledgment of receipt of this policy by students and parents will be given when signing the student handbook acknowledgment form.
3. In the event a student or employee does not understand the terms and conditions of this policy, it shall be the duty of the student, parent, or employee to ask for such points of clarification of the Superintendent of Schools or designee at the time this policy is distributed to the student, parent, or employee. If no question is directed by a student, parent, or employee to the Superintendent of Schools or designee, it shall be the legal position of the District to presume that the student, parent, or employee has understood and will abide by this policy.
4. It shall be the policy of the District to require the Superintendent of Schools to keep a statistical report of all violations of the District's policies and programs prohibiting the unlawful possession, use, or distribution of illicit drugs and alcohol by students and employees on the school district's property or as a part of any of the District's activities.
5. It shall be the policy of the District to biennially review its entire Drug Free Schools program to determine the effectiveness of the program and to implement such changes to the program as are deemed needed. The Superintendent shall undertake such study as is deemed appropriate to determine whether the program of the District as herein referred to is accomplishing its intended goals. If the Superintendent determines that changes are necessary or desirable in the program, the Superintendent shall present to the Board of Education, in odd numbered years, such changes as are proposed by the drug free schools committee in the program of the District.
6. It shall be the policy of the District to provide age appropriate developmentally based drug, tobacco, and alcohol education and prevention program for all students of the school. It shall also be the policy of the District to require instruction at each grade level concerning the adverse effects resulting from the use of illicit drugs, alcohol and tobacco. Such instruction shall be designed by affected classroom teachers or as otherwise directed by the Board to be appropriate to the age of the student exposed to such instruction. Such instruction should be described in any curriculum guides of the District and should have as one of its primary objectives preventing the use of illicit drugs, alcohol and tobacco by such students. It shall further be the policy of the District to encourage the use of outside resource personnel such as law enforcement officers, medical personnel, and experts on the subject of drug and alcohol abuse, so that its economic, social, educational, and physiological consequences may be made known to the students of the district. It shall further be the policy of the district through the instruction earlier herein referred to, as well as by information and consistent enforcement of the Board's policy pertaining to student conduct as it relates to the use of illicit drugs and the unlawful possession and use of alcohol and tobacco, that drug and alcohol abuse is wrong and is harmful both to the student and the District, and its educational programs.

Article 6 – Drug Free Schools

Student Sanctions

- 1A. Disciplinary Actions for Possession of Tobacco Products, including vapor products (such as e-cigarettes), alternative nicotine products, tobacco product look-alikes, and products intended to replicate tobacco products either by appearance or effect:
 - a. First Offense: The student will be assigned a Saturday Adjustment Class and assigned online prevention and intervention materials as determined by the principal.
 - b. Second Offense: The student will be placed on a three-day in-school suspension.
 - c. Third Offense: The student will be placed on a five-day in-school suspension.
 - d. Fourth Offense: The student will be placed on a three-day out-of-school suspension.Subsequent offenses may result in a recommendation for expulsion.
- 1B. Disciplinary Actions for Use of Tobacco Products, including vapor products (such as e-cigarettes), alternative nicotine products, tobacco product look-alikes, and products intended to replicate tobacco products either by appearance or effect:
 - a. First Offense: The student will be placed on a three-day in-school suspension and assigned online prevention and intervention materials as determined by the principal.
 - b. Second Offense: The student will be placed on five-day in-school suspension.
 - c. Third Offense: The student will be placed on five-day out-of-school suspension, but shall be given the option of having the suspension reduced to a three-day out-of-school suspension providing he/she agrees to undergo an evaluation for substance abuse and follows those recommendations made by a certified substance abuse evaluator. Any evaluation is at the expense of the student and/or parent/guardian. If the student fails to undergo the evaluation in a timely manner, he/she will serve the entirety of the five-day out of school suspension.Subsequent offenses may result in a recommendation for expulsion.
2. Disciplinary Action for Possession/Use/Under the Influence of Alcohol and/or Controlled Substance:
 - a. First Offense:
 - (1) The student shall be placed on a 19-day out-of-school suspension, but shall be given the option of having the long-term suspension reduced to a 5-day out-of-school suspension providing the student undergoes an evaluation for substance abuse and follows those recommendations made by a certified substance abuse evaluator. Any evaluation is at the expense of the student and/or parent/guardian. The school will provide a list of agencies providing evaluation services when requested.
 - (2) If a student fails to follow treatment recommendations, the remainder of the 19-day out-of school suspension shall be enforced.
 - (3) Prior to re-admission to school, the student, along with the parents, must meet with the Principal or his or her designee and counselor.
 - (4) The involved student shall be ineligible to participate in any co-curricular activities during the suspension.
 - b. Second Offense: The student will be placed on a 5-day out-of school suspension pending a recommendation for expulsion for the remainder of the current semester.
3. Disciplinary Actions for Students Selling, Giving, or Exchanging Alcohol and/or Controlled Substance:
 - a. First Offense: The student will be placed on a 5-day out-of school suspension pending a recommendation for expulsion for the remainder of the current semester.
 - b. Second Offense: The student will be placed on a 5-day out-of school suspension pending a recommendation for expulsion for the remainder of the current semester.

Information Referral

In the event of any non-compliance by any student with this policy it shall be the duty of the

Superintendent of Schools or designee to inform any student not in compliance about any drug and alcohol counseling and rehabilitation and re-entry programs that are available to the students within fifty (50) miles of the administrative offices of the District. If no such programs are available within 50 miles, then such other programs as may exist in the State of Nebraska shall be made known to such student. The Superintendent or designee shall maintain a list of such available services and shall from time to time update such list.

Student Acknowledgement

It shall be the policy of Mead Public Schools to provide each student of the District a copy of the standards of conduct for student behavior in the District which prohibit the unlawful possession, use, or distribution of illicit drugs, tobacco, including vapor products (such as e-cigarettes), alternative nicotine products, tobacco product look-alikes, and products intended to replicate tobacco products either by appearance or effect, and alcohol on school premises or as a part of any of the school related activities. Such standards of conduct and the District's policy of disciplinary sanctions that may be taken for violation of such standards of conduct shall be given to each student and his or her parent(s) or guardian at the commencement of each school year. This copy will be included in the student handbook and signature of the student handbook acknowledgment by the parent and student will signify receiving and understanding the policy. It shall further be the policy of the District to keep a file showing receipt of standards of conduct and a statement of disciplinary sanctions that may be taken for violations of such standards of conduct.

Section 2 Standards of Student Conduct Pertaining to Drugs, Alcohol and Tobacco.

In addition to the Standards of Conduct outlined in Policy 5131.7, the following conduct is prohibited on school premises, in school vehicles, or as part of any of the school's activities on or off school premises:

1. Being under the influence of any controlled substance, including but not limited to marijuana, any narcotic drug, any hallucinogen, any stimulant, or any depressant, including but not limited to prescription drugs.
2. Possession, use, distribution or being under the influence of alcohol.
3. Use, distribution, or being under the influence of any chemical substance including but not limited to abusable glue, aerosol paint, lighter fluid, whiteout, and reproduction fluid, when such activity constitutes misuse of the substance or a substantial interference with school purposes.
4. Possession, use, or distribution of any look-alike drug or look-alike controlled substance when such activity constitutes a substantial interference with school purposes.

Disciplinary Sanctions

Violation of any of the above prohibited acts, and those found in Policy 5131.7, will result in disciplinary sanction being taken within the bounds of applicable law, up to and including expulsion and referral to appropriate authorities for criminal prosecution. In particular, students should be aware that:

1. Violation of these standards may result in suspension or expulsion.
2. Prohibited substances will be confiscated and unlawful substances will be turned over to law enforcement authorities.
3. The student may be referred for counseling or treatment.
4. Parents or legal guardian will be notified.
5. Law enforcement will be notified.
6. If it appears there is imminent danger to the student, other students, school personnel, or students involved, emergency medical services will be contacted.

Article 7 – Student Conduct Rules

Development of Uniform Discipline System. It shall be the responsibility of the Superintendent, or his designee, to develop and maintain a system of uniform discipline. The discipline which may be imposed includes actions which are determined to be reasonably necessary to aid the student, to further school purposes, or to prevent interference with the educational process, such as (without limitation) counseling and warning students, parent contacts and parent conferences, rearrangement of schedules, requirements that a student remain in school after regular hours to do additional work, restriction of extracurricular activity, or requirements that a student receive counseling upon written consent of the parent or guardian, or in-school suspension. The discipline may also include out-of-school suspension (short-term or long-term) and expulsion. When a student is suspended or expelled, the student shall not be permitted on school grounds without specific administrator approval.

Administrative and teaching personnel may also take actions regarding student behavior, other than removal of students from school, which are reasonably necessary to aid the student, further school purposes, or prevent interference with the educational process. Such actions may include, but are not limited to, counseling of students, parent conferences, rearrangement of schedules, requirements that a student remain in school after regular hours to do additional work, restriction of extracurricular activity, or requirements that a student receive counseling, psychological evaluation, or psychiatric evaluation upon the written consent of a parent or guardian to such counseling or evaluation. The actions may also include in-school suspensions. When in-school suspensions, after-school assignments, or other disciplinary measures are assigned, the student is responsible for complying with such disciplinary measures. A failure to serve such assigned discipline as directed will serve as grounds for further discipline, up to expulsion from school.

Section 1 Purpose of Student Conduct Rules

These student conduct rules are established to maintain a school atmosphere which is conducive to learning, to aid student development, to further school purposes, and to prevent interference with the educational process. Violations of the rules will result in disciplinary action.

Section 2 Forms of School Discipline

A. Short-Term Suspension:

Students may be excluded by the Principal, or the Principal's designee, from school or any school function for a period of up to five school days (short-term suspension) on the following grounds:

1. Conduct that constitutes grounds for expulsion, whether the conduct occurs on or off school grounds; or
2. Other violations of rules and standards of behavior adopted by the Mead Public School's Board of Education or the administrative or teaching staff of the school, which occur on or off school grounds, if such conduct interferes with school purposes or there is a nexus between such conduct and school.
3. The following process will apply to short-term suspension:
 - (a) The Principal or Principal's designee shall make a reasonable investigation of the facts and circumstances. Such short-term suspension shall be made upon a determination that the suspension is necessary to help any student, to further school purposes, or to prevent an interference with school purposes.
 - (b) Prior to commencement of the short-term suspension, the student shall be given oral and written notice of the charges against the student. The student will be advised of what the student is accused of having done, an explanation of the evidence the authorities have, and be afforded an opportunity to explain the student's version of the facts.

- (c) Within 24 hours or such additional time as is reasonably necessary, not to exceed an additional 48 hours, following the suspension, the Principal or administrator shall send a written statement to the student and the student's parent or guardian describing (i) the student's conduct, misconduct, or violation of the rule or standard; (ii) the reasons for the action taken; (iii) the actions taken by the school to attempt to address or alleviate the behavior prior to suspension; (iv) resources the school is able to provide or recommend to assist the student; and (v) how the school plans to address the behavior moving forward, including strategies to maximize the student's continued participation in school.
- (d) An opportunity shall be given to the student, and the student's parent or guardian, to have a conference with the Principal or designee ordering the short-term suspension before or at the time the student returns to school. The Principal or administrator shall determine who in addition to the parent or guardian shall attend the conference. The Principal shall document their attempt to make a reasonable effort to hold a conference with the parent or guardian.

B. Long-Term Suspension: A long-term suspension means an exclusion from school and any school functions for a period of more than five school days but less than twenty school days. A student who is on a long-term suspension shall not be permitted to be on school grounds without the express permission of the Principal. A notice will be given to the student and the parents/guardian when the Principal recommends a long-term suspension. The notice will include a description of (i) the student's conduct, misconduct, or violation of the rule or standard; (ii) the reasons for the action taken; (iii) the actions taken by the school to attempt to address or alleviate the behavior prior to suspension; (iv) resources the school is able to provide or recommend to assist the student; and (v) how the school plans to address the behavior moving forward, including strategies to maximize the student's continued participation in school.

C. Expulsion:

1. **Meaning of Expulsion.** Expulsion means exclusion from attendance in all schools, grounds, and activities of or within the system for a period not to exceed the remainder of the semester in which it took effect unless the misconduct occurred (a) within ten school days prior to the end of the first semester, in which case the expulsion shall remain in effect through the second semester, or (b) within ten school days prior to the end of the second semester, in which case the expulsion shall remain in effect for summer school and the first semester of the following school year, or (c) unless the expulsion is for conduct specified in these rules or in law as permitting or requiring a longer removal, in which case the expulsion shall remain in effect for the period specified therein. Such action may be modified or terminated by the school district at any time during the expulsion period. A student who has been expelled shall not be permitted to be on school grounds without the express permission of the Principal. A notice will be given to the student and the parents/guardian when the Principal recommends an expulsion. The notice will include a description of: (i) the student's conduct, misconduct, or violation of the rule or standard; (ii) the reasons for the action taken; (iii) the actions taken by the school to attempt to address or alleviate the behavior prior to suspension; (iv) resources the school is able to provide or recommend to assist the student; and (v) how the school plans to address the behavior moving forward, including strategies to maximize the student's continued participation in school.
2. **Suspensions Pending Hearing.** When a notice of intent to discipline a student by long-term suspension, expulsion, or mandatory reassignment is filed with the superintendent, the student may be suspended by the Principal until the date the long-term suspension, expulsion,

or mandatory reassignment takes effect if the Principal determines that the student must be suspended immediately to prevent or substantially reduce the risk of (a) interference with the educational function or school purpose or (b) a personal injury to the student himself or herself, other students, school employees, or school volunteers. If the student is suspended pending the outcome of the hearing, the student may complete classwork and homework, including, but not limited to, examinations, missed during the period of suspension. During this period, the student will not be required to attend the alternative programs for expelled students in order to complete classwork or homework.

3. **Summer Review.** Any expulsion that will remain in effect during the first semester of the following school year shall be automatically scheduled for review before the beginning of the school year in accordance with law.
4. **Alternative Education.** Students who are expelled may be offered an alternative education program that will enable the student to continue academic work for credit toward graduation. A student will not be required to attend the alternative education program in order to complete classwork and homework. In the event an alternative education program is not provided, a conference will be held with the parent, student, the Principal or another school representative assigned by the Principal, and a representative of a community organization that assists young people or that is involved with juvenile justice to develop a plan for the student in accordance with law.
5. **Suspension of Enforcement of an Expulsion.** Enforcement of an expulsion action may be suspended (i.e. “stayed”) for a period of not more than one full semester in addition to the balance of the semester in which the expulsion takes effect. As a condition of such suspended action, the student and parents will be required to sign a discipline agreement.
6. **Students Subject to Juvenile or Court Probation.** Prior to the readmission to school of any student who is less than nineteen years of age and who is subject to the supervision of a juvenile probation officer or an adult probation officer pursuant to the order of the District Court, County Court, Juvenile Court, who chooses to meet conditions of probation by attending school, and who has previously been expelled from school, the Principal or Principal’s designee shall meet with the student’s probation officer and assist in developing conditions of probation that will provide specific guidelines for behavior and consequences for misbehavior at school (including conduct on school grounds and conduct during an educational function or event off school grounds) as well as educational objectives that must be achieved. If the guidelines, consequences, and objectives provided by the Principal or Principal’s designee are agreed to by the probation officer and the student, and the court permits the student to return to school under the agreed to conditions, the student may be permitted to return to school. The student may with proper consent, upon such return, be evaluated by the school for possible disabilities and may be referred for evaluation for possible placement in a special education program. The student may be expelled or otherwise disciplined for subsequent conduct as provided in Board Policy and state statute.
7. **Returning from Expulsion.** At the conclusion of an expulsion, the District will reinstate the student and accept nonduplicative, grade-appropriate credits earned by the student during the term of expulsion from any Nebraska accredited institution or institution accredited by one of the six regional accrediting bodies in the United States.
8. **Religious Freedom.** The District will not substantially burden a student’s right to religious exercise unless the student’s religious exercise is disruptive to the school environment, not permitted by staff, may pose a safety risk, or would otherwise interfere with the school day.

- D. In-School Suspension. Students assigned to ISS must complete their time appropriately before they are able to return to the classroom. Students assigned to ISS are not allowed to participate in events during the school day, unless the principal determines the event is of particular value to the situation and may be excluded from after school activities including practices, games, concerts, etc., if the ISS is assigned in lieu of Out of School Suspension. The following expectations have been established for ISS:
1. Academic work assigned and due during ISS must be completed, or the ISS may be extended until such work is satisfactorily completed.
 2. Students will report to ISS upon arrival to school and remain in ISS until the final bell unless other times have been arranged by the principal.
 3. No contact with other students is permitted during ISS.
 4. Electronic devices such as but not limited to cell phones, Ipods/pads, or laptops, are not permitted. Such devices must be checked in to the office until the end of the day.
 5. Students must remain awake and upright.
 6. Food and water will be permitted only as it would for students in the regular classroom.
 7. Restroom breaks will be on an as needed basis, but must not be misused.
 8. Students will have access to the lunch program, but may have a tray brought to them or be escorted to the cafeteria.
 9. Damaging, defacing, or vandalizing school property is not permitted.
 10. Failure to follow these expectations will result in the extension of ISS or a reassignment to out-of-school suspension.
- E. Emergency Exclusion
Emergency Exclusion: A student may be excluded from school in the following circumstances:
- a. If the student has a dangerous communicable disease transmissible through normal school contacts and poses an imminent threat to the health or safety of the school community; or
 - b. If the student's conduct presents a clear threat to the physical safety of himself, herself, or others, or is so extremely disruptive as to make temporary removal necessary to preserve the rights of other students to pursue an education.
- Any emergency exclusion shall be based upon a clear factual situation warranting it and shall last no longer than is necessary to avoid the dangers described above.
- If the emergency exclusion will be for five school days or less, the procedures for a short-term suspension shall be followed. If the Superintendent or his or her designee determines that an emergency exclusion shall extend beyond five days, a hearing is to be held and a final determination made within ten school days after the initial date of exclusion. Such procedures shall substantially comply with the procedures set forth in this policy for a long-term suspension or expulsion, and be modified only to the extent necessary to accomplish the hearing and determination within this shorter time period.
- F. Other Forms of Student Discipline. Administrative and teaching personnel may take actions regarding student behavior, other than removal of students from school, which are reasonably necessary to aid the student, further school purposes, or prevent interference with the educational process. Such actions may include, but are not limited to, counseling of students, parent conferences, rearrangement of schedules, requirements that a student remain in school after regular hours to do additional work, restriction of extracurricular activity, or requirements that a student receive counseling, psychological evaluation, or psychiatric evaluation upon the

written consent of a parent or guardian to such counseling or evaluation. When in-school suspensions, after-school assignments, or other disciplinary measures are assigned, the student is responsible for complying with such disciplinary measures. A failure to serve such assigned discipline as directed will serve as grounds for further discipline, up to expulsion from school.

Section 3 Student Conduct Expectations

Students are not to engage in conduct which causes or which creates a reasonable likelihood that it will cause a substantial disruption in or material interference with any school function, activity or purpose or interfere with the health, safety, well being or rights of other students, staff or visitors.

A. Grounds for Short-Term Suspension, Long-Term Suspension, Expulsion or Mandatory Reassignment

The following conduct has been determined by the Board of Education to have the potential to seriously affect the health, safety or welfare of students, staff and other persons or to otherwise seriously interfere with the educational process. Such conduct constitutes grounds for long-term suspension, expulsion, or mandatory reassignment, and any other lesser forms of discipline. The conduct is subject to the consequence of long-term suspension, expulsion, or mandatory reassignment where it occurs on school grounds, in a vehicle owned, leased, or contracted by the school and being used for a school purpose or in a vehicle being driven for a school purpose by a school employee or an employee's designee, or at a school-sponsored activity or athletic event. Mandatory reassignment shall be subject to the same procedural requirements and protections as long-term suspension and expulsion.

1. Willfully disobeying any reasonable written or oral request of a school staff member, or the voicing of disrespect to those in authority.
2. Use of violence, force, coercion, threat, intimidation, harassment, or similar conduct in a manner that constitutes a substantial interference with school purposes or making any communication that a reasonable recipient would interpret as a serious expression of an intent to harm or cause injury to another.
3. Willfully causing or attempting to cause substantial damage to property, stealing or attempting to steal property of substantial value, repeated damage or theft involving property, or setting or attempting to set a fire of any magnitude.
4. Causing or attempting to cause personal injury to any person, including any school employee, school volunteer, or student. Personal injury caused by accident, self-defense, or other action undertaken on the reasonable belief that it was necessary to protect some other person shall not constitute a violation of this subdivision.
5. Threatening or intimidating any student for the purpose of or with the intent of obtaining money or anything of value from such student or making a threat which causes or may be expected to cause a disruption to school operations.
6. Knowingly possessing, handling, or transmitting any object or material that is ordinarily or generally considered a weapon or that has the appearance of a weapon or bringing or possessing any explosive device, including fireworks.
7. Engaging in selling, using, possessing or dispensing of alcohol, tobacco, narcotics, drugs, controlled substance, or an inhalant; being under the influence of any of the above; possession of drug paraphernalia, or the selling, using, possessing, or dispensing of an imitation controlled substance as defined in section 28-401 of the Nebraska statutes, or material represented to be alcohol, narcotics, drugs, a controlled substance or inhalant. Tobacco means any tobacco product (including but not limited to cigarettes, cigars, and

chewing tobacco), vapor products (such as e-cigarettes), alternative nicotine products, tobacco product look-alikes, and products intended to replicate tobacco products either by appearance or effect. Use of a controlled substance in the manner prescribed for the student by the student's physician is not a violation. The term "under the influence" has a less strict meaning than it does under criminal law; for school purposes, the term means any level of impairment and includes even the odor of alcohol or illegal substances on the breath or person of a student; also, it includes being impaired by reason of the abuse of any material used as a stimulant.

8. Public indecency or sexual conduct. This includes "deep fakes" or other computer-generated images of other students or staff intended to bully, harass, intimidate, or humiliate another student or staff member.
9. Engaging in bullying, which includes any ongoing pattern of physical, verbal, or electronic abuse on school grounds, in a vehicle owned, leased, or contracted by a school being used for a school purpose by a school employee or a school employee's designee, or at school-sponsored activities or school-sponsored athletic events.
10. Sexually assaulting or attempting to sexually assault any person. This conduct may result in an expulsion regardless of the time or location of the offense if a complaint alleging such conduct is filed in a court of competent jurisdiction.
11. Engaging in any activity forbidden by law which constitutes a danger to other students or interferes with school purposes. This conduct may result in an expulsion regardless of the time or location of the offense if the conduct creates or had the potential to create a substantial interference with school purposes, such as the use of the telephone or internet off-school grounds to threaten.
12. A repeated violation of any rules established by the school district or school officials if such violations constitute a substantial interference with school purposes, including (but not limited to) a violation of the District's dress code and electronic communication rules.
13. Truancy or failure to attend assigned classes or assigned activities; or tardiness to school, assigned classes or assigned activities.
14. The use of language, written or oral, or conduct, including gestures, which is profane or abusive to students or staff members. Profane or abusive language or conduct includes, but is not limited to, that which is commonly understood and intended to be derogatory toward a group or individual based upon race, gender, disability, national origin, or religion.
15. Willfully violating the behavioral expectations for riding school buses or vehicles.
16. A student who engages in the following conduct shall be expelled for the remainder of the school year in which it took effect if the misconduct occurs during the first semester, and if the expulsion for such conduct takes place during the second semester, the expulsion shall remain in effect for the first semester of the following school year, with the condition that such action may be modified or terminated by the school district during the expulsion period on such terms as the administration may establish:
 - a. The knowing and intentional use of force in causing or attempting to cause personal injury to a school employee, school volunteer, or student, except if caused by accident, self-defense, or on the reasonable belief that the force used was necessary to protect some other person and the extent of force used was reasonably believed to be necessary, or
 - b. The knowing and intentional possession, use, or transmission of a dangerous weapon other than a firearm. The term "dangerous weapon" includes any

personal safety or security device (such as tasers, mace and pepper spray). If a student desires to carry or possess a personal safety or security device, the student must obtain prior approval from the building principal before bringing such device on school grounds. If a student obtains prior approval from the building principal, the student must store the device during the school day in the student's locker, in the main office or in another secure location designated by the building principal. A student shall not carry a personal safety or security device during the school day.

18. Knowingly and intentionally possessing, using, or transmitting a firearm on school grounds, in a school-owned or utilized vehicle, or during an educational function or event off school grounds, or at a school-sponsored activity or athletic event. This conduct shall result in an expulsion for one calendar year. "Firearm" means a firearm as defined in 18 U.S.C. 921, as that statute existed on January 1, 1995. That statute includes the following statement: "The term 'firearm' means (a) any weapon (including a starter gun) which will or is designed to or may readily be converted to expel a projectile by the action of an explosive; (b) the frame or receiver of any such weapon; (c) any firearm muffler or firearm silencer; or (d) any destructive device." The Superintendent may modify such one year expulsion requirement on a case-by-case basis, provided that such modification is in writing.

Bringing a firearm or other dangerous weapon to school for any reason is discouraged; however, a student will not be subject to disciplinary action if the item is brought or possessed under the following conditions:

- a. Prior written permission to bring the firearm or other dangerous weapon to school is obtained from the student's teacher, building administrator and parent.
- b. The purpose of having the firearm or other dangerous weapon in school is for a legitimate educational function.
- c. A plan for its transportation into and from the school, its storage while in the school building and how it will be displayed must be developed with the prior written approval by the teacher and building administrator. Such plan shall require that such item will be in the possession of an adult staff member at all times except for such limited time as is necessary to fulfill the educational function.
- d. The firearm or other dangerous weapon shall be in an inoperable condition while it is on school grounds.
- e. For personal safety or security devices, the student abides by the requirements set forth above.

B. Additional Student Conduct Expectations and Grounds for Discipline

The following additional student conduct expectations are established. Failure to comply with such rules is grounds for disciplinary action. When such conduct occurs on school grounds, in a vehicle owned, leased, or contracted by a school being used for a school purpose or in a vehicle being driven for a school purpose by a school employee or by his or her designee, or at a school-sponsored activity or athletic event, the conduct is grounds for long-term suspension, expulsion or mandatory reassignment.

Dress Code

1. Students are expected to dress in a way that is appropriate for the school setting. Students should not dress in a manner that is reasonably forecasted to interfere with the

learning environment or teaching process in our school. Following is a list of examples of attire that will not be considered appropriate, such list is not exclusive and other forms of attire deemed inappropriate by the administration may be deemed inappropriate for the school setting:

- a. Clothing that shows an inappropriate amount of bare skin or underwear or clothing that is too tight, revealing or baggy, or tops and bottoms that do not overlap or any material that is sheer or lightweight enough to be seen through, or otherwise of an appropriate size and fit so as to be revealing or drag on the ground.
- b. Clothing or jewelry that advertises or promotes beer, alcohol, tobacco, or illegal drugs.
- c. Clothing or jewelry that could be used as a weapon (chains, spiked apparel) or that would encourage “horse-play” or that would damage property (e.g. cleats).
- d. Head wear including hats, caps, bandannas, and scarves.
- e. Clothing or jewelry which exhibits nudity, makes sexual references or carries lewd, indecent, or vulgar double meaning.
- f. Clothing or jewelry that is gang related.

A student who is a member of an indigenous tribe of the United States or another country may wear tribal regalia in any location where the student is authorized to be on such school grounds or at any school function, as long as the tribal regalia does not interfere with the educational process and does not endanger another person, as determined by the administration. Further, students will also be permitted to wear attire, including religious attire, natural and protective hairstyles, adornments or other characteristics associated with race, national origin, or religion, as long as the attire does not interfere with the educational process and does not endanger another person, as determined by the administration.

No student shall be disproportionately affected by a dress code or grooming policy enforcement because of the student's gender, race, color, religion, disability, or national origin.

No school staff shall permanently or temporarily alter or cut a student's hair.

The final decision regarding attire and grooming will be made by the Principal or Superintendent. In the event a student is uncertain as to whether a particular item or method of grooming is consistent with the school's guidelines, the student should contact the Principal for approval, and may also review such additional posting of prohibited items or grooming which may be available in the Principal's office.

Electronic Devices

- 1. Philosophy and Purpose.** The District strongly discourages students from misusing electronic devices at school. The use of electronic devices can be disruptive to the educational process and are items that are frequently lost or stolen. In order to maintain a secure and orderly learning environment, and to promote respect and courtesy regarding the use of electronic devices, the District hereby establishes the following rules and regulations governing student use of electronic devices, and procedures to address student misuse of electronic devices. Students contacting or being contacted by parents via cell phone at times other than those permitted are still subject to

consequences.

2. **Definitions.** “Electronic devices,” include, but are not limited to, cell phones, Mp3 players, iPods, personal digital assistants (PDAs), compact disc players, portable game consoles, cameras, digital scanners, laptop computers, smart watches, and other electronic or battery powered instruments which transmit voice, text, or data from one person to another. Additional cell phones guidelines are included.

3. **Possession and Use of Electronic Devices.**

- (a) Students are not permitted to use any personal electronic devices during the school day except as otherwise provided by this policy. Staff members may require students to check in personal electronic devices during an instructional period. Personal electronic device usage, including but not limited to voice usage, digital imaging, or text messaging, is strictly prohibited during the school day unless permitted by the exceptions listed within the cell phone guidelines.
- (b) Students are permitted to possess and use electronic devices before school hours prior to entering the school building and after school hours, provided that the student not commit any abusive use of the device (see paragraph (4)(a).
- (c) School issued electronic devices may be used during class time when specifically approved by the teacher or a school administrator in conjunction with appropriate and authorized class or school activities or events (i.e., student use of a camera during a photography class; student use of a laptop computer for a class).
- (d) Students may use personal electronic devices during class time when authorized pursuant to an Individual Education Plan (IEP), a Section 504 Accommodation Plan, or a Health Care Plan, or pursuant to a plan developed with the student’s parent when the student has a compelling need to have the device.

4. **Violations**

- (a) Students shall not use electronic devices at any time or place for: (1) activities which disrupt the educational environment; (2) illegal activities in violation of state or federal laws or regulations; (3) unethical activities, such as cheating on assignments or tests; (4) immoral or pornographic activities; (5) activities in violation of Board or school policies and procedures relating to student conduct and harassment; (6) recording others (photographs, videotaping, sound recording, etc.) or otherwise transmitting images and/or sounds of another person or persons without direct administrative approval and consent of the person(s) being recorded, other than recording of persons participating in school activities that are open to the public; (7) “sexting;” or (8) activities which invade the privacy of others. Such student misuses will be dealt with as serious school violations, and immediate and appropriate disciplinary action will be imposed, including, but not limited to, suspension and expulsion from school.
- (b) Electronic devices used in violation of this policy may be confiscated by school personnel and returned to the student or parent/guardian at an appropriate time. If an electronic device is confiscated, the electronic device shall be taken to the school’s main office to be identified, placed in a secure area, and returned to the student and/or the student’s parent/guardian in a consistent and orderly way. Phones and devices checked in during an instructional period must be turned off. Failure to turn devices to the appropriate setting will result in consequences similar to those for inappropriate use.
- (c) **First Violation:** Depending upon the nature of the violation and the imposition of other appropriate disciplinary action, consequences at a minimum may include a relinquishment of the electronic device to the school administration and a conference between the student and school principal or principal’s designee. The electronic device shall remain in the

possession of the school administration for the remainder of the school day, when the student may personally come to the school's main office to retrieve the device. Failure or refusal to submit a cell phone or device will result in a minimum of a 30-minute detention.

- (d) **Second Violation:** Depending upon the nature of the violation and the imposition of other appropriate disciplinary action, consequences at a minimum may include a relinquishment of the electronic device to the school administration, a conference between the student and his/her parent/guardian and the school principal or principal's designee, and a 30-minute detention. The electronic device shall remain in the possession of the school administration for the remainder of the school day, when the student may personally come to the school's main office to retrieve the device. A second failure or refusal to submit a cell phone or device will result in a minimum of a 60-minute detention.
- (e) **Third Violation:** Depending upon the nature of the violation and the imposition of other appropriate disciplinary action, consequences at a minimum may include a relinquishment of the electronic device to the school administration, a conference between the student and his/her parent/guardian and the school principal or principal's designee, and a 60-minute detention. The electronic device shall remain in the possession of the school administration until such time as the student's parent/guardian personally comes to the school's main office and retrieves the electronic device. A third failure or refusal to submit a cell phone or device will result in an In-School Suspension.
- (f) **Subsequent Violations:** Students who are repeat offenders of this policy shall be subject to the imposition of any appropriate disciplinary action, which may include suspension and expulsion from school.

5. Responsibility for Electronic Devices. Students or their parents/guardians are expected to claim a confiscated electronic device within ten (10) days of the date it was relinquished. The school shall not be responsible, financially or otherwise, for any unclaimed electronic devices. By bringing such devices to school, students and parents authorize the school to dispose of unclaimed devices at the end of each semester. The District is not responsible for the security and safekeeping of students' electronic devices and is not financially responsible for any damage, destruction, or loss of electronic devices.

Cell Phone and Electronic Device Guidelines

All students are prohibited from accessing or using an electronic communication device while on school property or attending a school instructional function, unless:

1. When required by a student's Individualized Education Program or 504 Plan;
2. When authorized by the District for educational purposes during instructional time;
3. In the case of an emergency or perceived threat of danger;
4. When necessary to monitor or manage a student's health care; or
5. When determined appropriate by the Superintendent or Superintendent's designee.

All exceptions listed herein must be approved in advance by the appropriate school staff member. Appropriate school staff members include the Superintendent or the Superintendent's designee, i.e. administrators and school counselors.

At the Junior-Senior High building, personal electronic communication devices will be kept off and out of sight upon entering the building and throughout the school day, including passing periods and lunch time.

Harassment and Bullying Policy

One of the missions of Mead Public Schools is to provide safe and secure environments for all students and staff. Positive behaviors (non-violence, cooperation, teamwork, understanding, and acceptance of others) are encouraged in the educational program and required of all students and staff. Inappropriate behaviors including but not limited to bullying, cyberbullying, intimidation and harassment are to be identified and corrected. Students and staff are to avoid such behaviors. Strategies and practices are implemented to reinforce positive behaviors and to discourage and protect others from inappropriate behaviors.

“Bullying” is behavior where one person or group engages in harmful action towards another person or group acting on a real or perceived imbalance of power or view of superiority. The behavior typically includes verbal (e.g. teasing or name-calling) and physical aggression (e.g., hitting, pushing), threatening, excluding or ignoring, spreading rumors, or taking, defacing or destroying the others’ property. “Harassment” includes the same actions, though not necessarily from a standpoint of perceived power. Harassment is prohibited. Bullying and harassment is a violation of student conduct rules and appropriate disciplinary measures, up to expulsion, will be enforced. When bullying or harassment is done on the basis of gender, disability, race, or other protected status, it is considered a very serious offense for which expulsion may be a likely consequence depending on the severity of the conduct.

Students who are the victim of bullying or harassment or who observe such occurring are to promptly report the problem to their teacher or to the Principal so the problem can be addressed. Students who make reports of bullying activity will not be retaliated against for making the report.

Student Internet Use

A. Internet Safety Policy

It is the policy of Mead Public School to comply with the Children’s Internet Protection Act (CIPA). With respect to the District’s computer network, the District shall: (a) prevent user access to, or transmission of, inappropriate material via Internet, electronic mail, or other forms of direct electronic communications; (b) provide for the safety and security of minors when using electronic mail, chat rooms, and other forms of direct electronic communications; (c) prevent unauthorized access, including so-called “hacking,” and other unlawful activities online; (d) prevent unauthorized online disclosure, use, or dissemination of personal identification information of minors; and (e) implement measures designed to restrict minors’ access to materials (visual or non-visual) that are harmful to minors.

1. Definitions. Key terms are as defined in CIPA. “Inappropriate material” for purposes of this policy includes material that is obscene, child pornography, or harmful to minors. The term “harmful to minors” means any picture, image, graphic image file, or other visual depiction that: (1) taken as a whole and with respect to minors, appeals to a prurient interest in nudity, sex, or excretion; (2) depicts, describes, or represents, in a patently offensive way with respect to what is suitable for minors, an actual or simulated sexual act or sexual contact, actual or simulated normal or perverted sexual acts, or a lewd exhibition of the genitals; (3) taken as a whole, lacks serious literary, artistic, political, or scientific value as to minors; or (4) cyberbullying, which includes the intent to harass insult or attack others via the internet, local area networks, or wireless networks.
2. Access to Inappropriate Material. To the extent practical, technology protection measures (or “Internet filters”) shall be used to block or filter Internet, or other forms of electronic communications, access to inappropriate information. Specifically, as required by the CIPA, blocking shall be applied to visual depictions of material deemed obscene or child pornography, or to any material deemed harmful to minors. Subject to staff supervision,

technology protection measures may be disabled or, in the case of minors, minimized only for bona fide research or other lawful purposes.

3. Inappropriate Network Usage. To the extent practical, steps shall be taken to promote the safety and security of users of the District's online computer network when using electronic mail, chat rooms, instant messaging, and other forms of direct electronic communications. Specifically, as required by CIPA, prevention of inappropriate network usage includes: (a) unauthorized access, including so-called 'hacking,' and other unlawful activities; and (b) unauthorized disclosure, use, and dissemination of personal identification information regarding minors.
4. Supervision and Monitoring. It shall be the responsibility of all members of the District staff to supervise and monitor usage of the online computer network and access to the Internet in accordance with this policy and CIPA. Procedures for the disabling or otherwise modifying any technology protection measures shall be the responsibility of the Superintendent and the Superintendent's designees.
5. Social Networking. Students shall be educated about appropriate online behavior, including interacting with others on social networking websites and in chat rooms, and cyberbullying awareness and response. The plan shall be for all students to be provided education on these subjects. The Superintendent or the Superintendent's designee shall be responsible for identifying educational materials, lessons, and/or programs suitable for the age and maturity level of the students and for ensuring the delivery of such materials, lessons, and/or programs to students.
6. Adoption. This Internet Safety Policy was adopted by the Board at a public meeting, following normal public notice.

B. Computer Acceptable Use Policy

This computer acceptable use policy is supplemental to the District's Internet Safety Policy.

1. Technology Subject to this Policy. This Computer Acceptable Use Policy applies to all technology resources of the District or made available by the District. Technology resources include, without limitation, computers and related technology equipment, all forms of e-mail and electronic communications, and the internet.
2. Access and User Agreements. Use of the District technology resources is a privilege and not a right. The Superintendent or designee shall develop appropriate user agreements and shall require that employees, students (and their parents or guardians), and others to sign such user agreements as a condition of access to the technology resources, as the Superintendent determines appropriate.
The Superintendent and designees are authorized and directed to establish and implement such other regulations, forms, procedures, guidelines, and standards to implement this Policy.
The technology resources are not a public forum. The District reserves the right to restrict any communications and to remove communications that have been posted.
3. Acceptable Uses. The technology resources are to be used for the limited purpose of advancing the District's mission. The technology resources are to be used, in general, for educational purposes, meaning activities that are integral, immediate, and proximate to the education of students as defined in the E-rate program regulations.
4. Unacceptable Uses.
The following are unacceptable uses of the technology resources:
 - a. **Personal Gain:** Technology resources shall not be used, and no person shall authorize its use, for personal financial gain other than in accordance with

prescribed constitutional, statutory, and regulatory procedures, other than compensation provided by law.

- b. **Personal Matters:** Technology resources shall not be used, and no person shall authorize its use, for personal matters.
Occasional use that the Superintendent or designee determines to ultimately facilitate the mission of the District is not prohibited by this provision. Examples of occasional use that may be determined to ultimately facilitate the mission of the District: sending an e-mail to a minor child or spouse; sending an e-mail related to a community group in which an employee is a member where the membership in the community group facilitates the District's mission.
This occasional use exception does not permit use by employees contrary to the expectations of their position. For example, employees may not play games or surf the net for purposes not directly related to their job during duty time; nor may students do so during instructional time.
The occasional use exception also does not permit use of the technology resources for private business, such as searching for or ordering items on the internet for non-school use; or sending an e-mail related to one's own private consulting business.
- c. **Campaigning:** Technology resources shall not be used, and no person shall authorize its use, for the purpose of campaigning for or against the nomination or election of a candidate or the qualification, passage, or defeat of a ballot question.
- d. **Technology-Related Limitations:** Technology resources shall not be used in any manner which impairs its effective operations or the rights of other technology users. Without limitation,
 - 1. Users shall not use another person's name, log-on, password, or files for any reason, or allow another to use their password (except for authorized staff members).
 - 2. Users shall not erase, remake, or make unusable another person's computer, information, files, programs or disks.
 - 3. Users shall not access resources not specifically granted to the user or engage in electronic trespassing.
 - 4. Users shall not engage in "hacking" to gain unauthorized access to the operating system software or unauthorized access to the system of other users.
 - 5. Users shall not copy, change, or transfer any software without permission from the network administrators.
 - 6. Users shall not write, produce, generate, copy, propagate, or attempt to introduce any computer code designed to self-replicate, damage, or otherwise hinder the performance of any computer's memory, file system, or software. Such software is often called a bug, virus, worm, Trojan horse, or similar name.
 - 7. Users shall not engage in any form of vandalism of the technology resources.
 - 8. Users shall follow the generally accepted rules of network etiquette. The Superintendent or designees may further define such rules.
- e. **Other Policies and Laws:** Technology resources shall not be used for any purpose contrary to any District policy, any school rules to which a student user is subject,

or any applicable law. Without limitation, this means that technology resources may not be used:

1. to access any material contrary to the Internet Safety Policy; or to create or generate any such material.
 2. to engage in cyberbullying, unlawful harassment, or discrimination, such including by not limited to sending e-mails that contain sexual jokes or images.
 3. to engage in violations of employee ethical standards and employee standards of performance, such as sending e-mails that are threatening or offensive or which contain abusive language; use of end messages on e-mails that may imply that the District is supportive of a particular religion or religious belief system, a political candidate or issue, or a controversial issue; or sending e-mails that divulge protected confidential student information to unauthorized persons.
 4. to engage in or promote violations of student conduct rules.
 5. to engage in illegal activity, such as gambling.
 6. in a manner contrary to copyright laws.
 7. in a manner contrary to software licenses.
5. Disclaimer. The technology resources are supplied on an “as is, as available” basis. The District does not imply or expressly warrant that any information accessed will be valuable or fit for a particular purpose or that the system will operate error free. The District is not responsible for the integrity of information accessed, or software downloaded from the Internet.
6. Filter. A technology protection measure is in place that blocks and/or filters access to prevent access to Internet sites that are not in accordance with policies and regulations. In addition to blocks and/or filters, the District may also use other technology protection measures or procedures as deemed appropriate.

Notwithstanding technology protection measures, some inappropriate material may be accessible by the Internet, including material that is illegal, defamatory, inaccurate, or potentially offensive to some people. Users accept the risk of access to such material and responsibility for promptly exiting any such material.

The technology protection measure that blocks and/or filters Internet access may be disabled only by an authorized staff member for bona fide research or educational purposes: (a) who has successfully completed District training on proper disabling circumstances and procedures, (b) with permission of the immediate supervisor of the staff member requesting said disabling, or (c) with the permission of the Superintendent. An authorized staff member may override the technology protection measure that blocks and/or filters Internet access for a minor to access a site for bona fide research or other lawful purposes provided the minor is monitored directly by an authorized staff member.

7. Monitoring. Use of the technology resources, including but not limited to internet sites visited and e-mail transmitted or received, is subject to monitoring by the administration and network administrators at any time to maintain the system and insure that users are using the system responsibly, without notice to the users. Users have no privacy rights or expectations of privacy with regard to use of the District’s computers or Internet system. All technology equipment shall be used under the supervision of the Superintendent and the Superintendent’s designees.

Sanctions. Violation of the policies and procedures concerning the use of the District technology resources may result in suspension or cancellation of the privilege to use the technology resources and disciplinary action, up to and including expulsion of students and termination of employees. Use that is unethical may be reported to the Commissioner of Education. Use that is unlawful may be reported to the law enforcement authorities. Users shall be responsible for damages caused and injuries sustained by improper or non-permitted use. Students should be aware violations may result in disciplinary action including but not limited to loss of access to the Internet and/or local area network as well as the student's school assigned device.

First Offense: Detention or other disciplinary action as determined by administration. Extreme offenses can be escalated.

Second Offense: Limited internet access and/or the disciplinary actions for a previous offense as determined by administration.

Third Offense: Limited access to network and/or student device and/or the disciplinary actions for a previous offense as determined by administration.

Fourth Offense: Loss of access to network and device and/or the disciplinary actions for a previous offense as determined by administration.

Please note, the severity of an offense, even if it is a first offense, will be considered when determining the level of disciplinary action.

Risks of Social Media:

The purpose of this message is to give students information about the risks of using Facebook and similar social networking sites. Information on social networking sites may affect students at school. Pictures or writings that show that a student has violated student conduct rules may result in school discipline. For example, a picture of a student consuming alcohol may very well lead to a suspension from activities if the school learns about it. Criminal charges may be filed against students based on information posted on social networking sites.

Section 4 Reporting Student Law Violations:

Any act of a student which is a basis for expulsion and which the principal or designee knows or suspects is a violation of the Nebraska Criminal Code will be reported to law enforcement as soon as possible. Conduct to be reported for law enforcement referral includes conduct that may constitute a felony, conduct which may constitute a threat to the safety or well-being of students or others in school programs and activities, and conduct that the legal system is better equipped to address than school officials. Conduct that does not need to be reported for law enforcement referral includes typical adolescent behavior that can be addressed by school administrators without the involvement of law enforcement. In making the decision of whether to report, consideration should be given to the student's maturity, mental capacity, and behavioral disorders, where applicable.

When appropriate, it shall be the responsibility of the referring administrator to contact the student's parent of the fact that the referral to legal authorities has been or will be made.

When a principal or other school official releases a minor student to a peace officer (e.g., police officer, sheriff, and all other persons with similar authority to make arrests) for the purpose of removing the minor from the school premises, the principal or other school official shall take immediate steps to notify the parent, guardian, or responsible relative of the minor regarding the release of the minor to the officer and regarding the place to which the minor is reportedly being taken, except when a minor has been taken

into custody as a victim of suspected child abuse, in which case the principal or other school official shall provide the peace officer with the address and telephone number of the minor's parents or guardian.

Police Questioning of Student

It is the philosophy and belief of the administration at Mead Public Schools that the responsibility for dealing with student discipline violations rests with us. Thus, we will make every effort to handle such problems in-house, according to the policies and procedures established by the district and the school. However, when violations of state laws or city ordinances occur, or when students or parents refuse to work within the established policies of the district and school, or where security of persons or property appears to be in jeopardy, we will not hesitate to call the police and initiate arrest and prosecution proceedings. In the event the police desire to talk to a student during school time, the school shall make reasonable efforts to contact the student's parent/guardian before the interview, in order that one of such persons can be present if he/she desires. In certain situations, parents may not be contacted prior to questioning by law enforcement.

Reporting Child Abuse

Teachers are required by law to report any suspected case of child abuse or neglect to the office. Abuse or neglect can be placing the child in a situation that endangers his/her life or physical or mental health, cruel confinement or punishment, deprivation of food clothing, shelter, care, sexual abuse, or being left unattended.

Section 5 Corrective and Disciplinary Techniques

Level 1: Teacher and student resolve the problem. Teachers will use appropriate district approved strategies to resolve minor issues. Teachers will use three corrective teaching strategies before a staff-supervised detention is assigned. Though a staff-supervised detention may be issued any time a teacher deems it appropriate, teachers are encouraged to require the student to serve a classroom detention before issuing a staff-supervised detention.

Level 2: Staff-supervised detention(s)/consequences. Only 3 behavior related detentions will be allowed before moving to the next level.

Level 2, 3 & 4 referrals are the accumulation of all teachers, not just one individual teacher. The severity of the incident or the accumulations of several incidents may cause several steps to be bypassed. This decision is left to the discretion of the Principal.

The following is representative of the types of corrective disciplinary measures available but is not all inclusive:

Detention

Detention period is a time when the student is assigned to stay after school for school rule violation or an infraction of acceptable behavior. Detention periods are scheduled on Monday-Thursday from 3:30 until 4:00 or 4:30. If a student misses an assigned detention due to absence from school, it will automatically be moved to the next available night. It is the student's responsibility to attend the next evening unless other arrangements are made with the principal or their designee.

Students should understand that any certified or support staff member in the building has the authority to correct misconduct at any time. Therefore, it is conceivable that any staff member may assign a detention to a student who is violating school rules. Once a student has been assigned three behavior-based detentions, he or she will automatically move to a one-hour detention from 3:30 until 4:30.

Detention Period Rules

1. Detentions will be held in the classroom of the assigned teacher for the assigned time.
2. If a student shows up after 3:30 p.m. without approval, he/she may be requested to stay for the entire assigned time, and may be assigned additional detention days.
3. Detention time should be used to work on academic work or read.
4. Students will be silent the entire time.
5. Students will not be allowed to leave the room without the permission of the monitor.
6. Failure to attend an assigned detention without prior approval of the Principal will generally result in the assignment of an additional detention according to the detention schedule.
7. Failure to report for a doubled detention may result in assignment to Saturday School.
8. Bus riders shall not be exempt from detention periods. They shall, however, be allowed sufficient time to make arrangements for a ride home before they serve their detention periods.

Saturday School

Saturday School may be used for disciplinary or attendance purposes. Saturday School students are assigned to a supervised study class on Saturday. Saturday School students attend regular classes during the week. Failure to follow Saturday School rules may lead to suspension, or expulsion. Additional regulations include but are not limited to the following:

1. Saturday School is held in the classroom of the assigned teacher from 8:00-11:00 a.m.
2. Students must attend on the day assigned. If for some reason a student is unable to attend, arrangements or a phone call prior to the scheduled absence to the designated school official for the Saturday School is required. Voicemail is available.
3. Students must bring school work/materials and work the entire time.
4. Students are allowed to go to their lockers at the discretion of the supervisor.
5. Students removed from Saturday School for any disciplinary infraction will lose credit for attendance

and will be subject to further disciplinary action.

6. Transportation is not provided.

Penalties for Failure to Attend (FTA) an assigned Saturday School: Students who fail to attend Saturday School will not be allowed to participate in activities until the assigned Saturday School is made up.

1st FTA - Make up Saturday School – Serve an additional Saturday School

2nd FTA - 2 days school suspension - Make up Saturday School

3rd FTA - 3 days school suspension - Make up Saturday School

Additional FTA's may result in recommendation for expulsion.

Article 8 - Co-curricular Activities

Section 1 Co-curricular Activity Policy

A. Philosophy

The expectations for the students given the opportunity to participate in co-curricular activities include not only behavior at school or school functions or events, but go beyond the school day and into the community. Participants need to remember that they are not only representing themselves, but also, their school and community in all their actions. We think of our participants as being special in that certain responsibilities are expected of them. Participants in co-curricular activities owe it to themselves to get the greatest possible good from their school experiences and derive some of the individual values and benefits of the programs. Students in these activities assume a leadership role when they are participating in these events. The student body, the community and other communities judge our school on the students' conduct and attitudes, and how they contribute to our school spirit and community image. The students' performance and devotion to high ideals make their school and community proud of them. Co-curricular activities have an important place in the educational scheme and it is a privilege that the students be accepted into the program and their support of cooperation, patience, pride, character, self-respect, self-discipline, teamwork, sportsmanship, and respect for authority.

B. Definition of a Co-curricular activity

A co-curricular activity is defined to include but not limited to all NSAA school sponsored activities, and any other school-sponsored clubs/organizations with judged or rated activities. The policy is not intended to cover activities constituting a portion of a student's academic grade. All other activities and/or school-sponsored events will be covered by the regulations as set forth in the student handbook or Mead Board of Education policy manual.

C. Introduction

The expectations for the students given the opportunity to participate in co-curricular activities include not only behavior at school or school functions or events, but go beyond the school day and into the community. Participants need to remember that they are not only representing themselves, but also, their school and community in all of their actions.

Participants in co-curricular activities owe it to themselves to get the greatest possible good from their school experiences and derive some of the individual values and benefits of the programs. Students in these activities assume a leadership role when they are participating in these events. The student body, the community and other communities judge our school on the students' conduct and attitudes, and how they contribute to our school spirit and the community image. The students' performance and devotion to high ideals make their school and community proud.

Co-curricular activities have an important place in the educational program of the Mead Public School District; it is a privilege for the student who chose to participate; students who participate and are accepted into the program are expected to demonstrate cooperation, patience, pride, character, self respect, self discipline, teamwork, sportsmanship, and respect for authority. It is the belief that accepting responsibility for one's actions is a part of that philosophy.

D. Citizenship

Participants are expected to model good citizenship at all times by conducting themselves in a manner that reflects positively upon themselves, our school and the Mead community. (Behavior representative of a good citizen shall generally mean, but not limited to, the following definition: "One who gives special emphasis to common honesty, morality, courtesy, obedience to law, respect for the Constitution of the United States, and the Constitution of the State of Nebraska, respect for peers, parents, school, the home and other lessons of a steady influence which tend to promote and develop an upright and desirable citizenry.")

E. Conduct

Participants shall refrain from engaging in activities that constitute a violation of the laws of the community, State or the United States. This shall include any and all unlawful activity other than a minor traffic offense (3-point violation or less).

F. Attendance and Academics

(1) Participants are expected to attend school regularly and show evidence of sincere effort towards scholastic achievement.

(2) Participants are expected to be on time for all practices, contests and departure for contests. In the event a participant is unable to attend a practice or contest, contact should be made with their sponsor in advance.

(3) Attendance, for the full day, the day of a contest or practice is required to be eligible for the practice or contest that day. Arrangements in advance for extenuating circumstances, such as doctor/dentist appointments, funerals or other activities, can be made with the building principal in writing. Every attempt should be made to be in attendance the day of a contest. Sleeping in to rest up for the game will not be considered an extenuating circumstance, nor will going home ill and then returning to play in the contest later that day.

G. Appearance

Participants will dress appropriately for the activity in which they are involved and will at all times maintain a neat, clean and well-groomed appearance.

H. Activities Regulation

Any student of Mead Junior High or Senior High shall be suspended from the co-curricular activity program if it is determined that the student has broken the laws of the State of Nebraska (except minor traffic violations, where the student loses 3 or fewer points on his/her driver's license), has possession of or use of tobacco, including vapor products (such as e-cigarettes), alternative nicotine products, tobacco product look-alikes, and products intended to replicate tobacco products either by appearance or effect, alcohol, illegal drugs or any other forms of chemical abuse, or has been involved in conduct unbecoming to a student involved in the co-curricular activity program. All violations involving unlawful conduct shall be reported by any school official or staff member and may be reported by any student to the Activities Director or the Sponsor involved. Any school official shall report violation by reason of "conduct unbecoming a student involved in the co-curricular activities program." A student who has engaged in a violation of the co-curricular policy may be subject to further discipline for the same violation in accordance with the rules as stated in the Mead Jr.-Sr. High School Student Handbook.

I. Penalties for Specific Conduct

Consequences for all penalties are accumulative for grades 7-8 & 9-12. If an offense is beyond the amount listed, the offense shall qualify for the most severe consequences available. Students will be suspended from the highest level of competition at which they commonly participate. They will be ineligible for all levels of participation until suspension from the highest level is completed. Co-curricular suspensions shall apply to all activities in which a student participates. For example, a student who participates in volleyball, yell squad, choir, and FFA, will serve suspensions from all these activities according to the Co-Curricular Consequences by Contest chart. Students who do not participate in activities may be suspended from attending extra-curricular events as spectators.

Tobacco

Any student determined by any school staff member to be engaged in tobacco, including vapor products (such as e-cigarettes), alternative nicotine products, tobacco product look-alikes, and products intended to replicate tobacco products either by appearance or effect, use/possession on/off school property or during any educational function or event on/off school property. (Determined is meant to include, but not limited to: observation by a staff member, designated adult supervisor, admission by the student, or other reasonably reliable information), shall be subject to the following penalties:

- 1st time** Level One Suspension (student would still attend practices and meetings).
2nd time Level Three Suspension (student would still attend practices and meetings).
3rd time Suspended from participating in all events/contest of the co-curriculum for the remainder of the school year.

Alcohol and Drugs

Any student determined by any school staff member to be engaged in unlawful possession or use of alcoholic liquor, illicit drug, or controlled substance on/off school property or during any educational function or event on/off school property. (Determined is meant to include, but not limited to: observation by a staff member, designated adult sponsor, admission by the student, or other reasonably reliable information), shall be subject to the following penalties:

- 1st time** -- Up to Level Three Suspension (student would still attend practices and meetings).
2nd time -- Suspended from participating in all events/contests of the co-curriculum for the remainder of the school year.

Citation for Law Violation

Any student cited and/or charged by any Law Enforcement Agency for a criminal offense or in a Juvenile Court for behavior which would constitute a criminal offense, upon confirmation of facts to support such charge by a school official; shall be subject to the following penalties:

- 1st time** -- Up to Level Three Suspension (student would still attend practices and meetings).
2nd time -- Suspended from participating in all events/contests of the co-curriculum for the remainder of the school year.

Illegal Activities

Any student engaging in any other activity forbidden by the laws of the State of Nebraska while on school property which constitutes a danger to other students or interferes with school purposes, shall be subject to the following penalties:

- 1st time** -- Up to Level Three Suspension (student would still attend practices and meetings).
2nd time -- Up to Level Four Suspension (student would still attend practices and meetings).
3rd time -- Suspended from participating in all events/contests of the co-curriculum for the remainder of the school year.

The wording of certain first time violations suggests that the consequences for the violation can be reduced. Prior to 2007-2008, however, no criteria existed for reducing the level of a suspension. A Level Three Suspension may be reduced to Level Two if the student willingly admits the violation when questioned by school authorities, and the student agrees to the appropriate evaluation and counseling. A Level Three Suspension may be reduced to Level One if the violation is willingly self-reported, and the student agrees to the appropriate evaluation and counseling. Level Four Suspensions cannot be reduced.

Article 8 – Co-Curricular Activities

Co-curricular suspensions shall apply to all activities in which a student participates. For example, a student who participates in volleyball, yell squad, choir, and FFA, will serve suspensions from all these activities according to the Co-Curricular Consequences by Contest chart. For suspension purposes, co-curricular activities may be divided into Fall, Winter, and Spring periods. Students who participate in multiple activities during a co-curricular period will be subject to suspension for all activities during the period in which the violation occurs. For example, a student participating in volleyball and yell squad during the Fall period will be suspended from both activities. If the number of contests cannot be met during that season, or the violation occurs between active participation period of these seasons, the suspension will be carried over to the next, comparable season.

Unbecoming Conduct

Any student determined to be engaged in "conduct unbecoming a student involved in the co-curricular program," shall be subject to the following penalties. (Determined is meant to include, but not limited to observation by a staff member or admission by the student or other reasonably reliable information.)

1st time -- Up to Level Three Suspension (student would still attend practices and meetings).

2nd time -- Up to Level Four Suspension from participating in all events/contests of the co-curriculum (student would still attend practices and meetings).

3rd time -- Suspended from participating in all events/contests of the co-curriculum for the remainder of the school year.

J. Enforcement Period

The enforcement period of this policy will begin with the official starting day of the fall sport season established by the Nebraska School Activities Association and will end on the last official day of school in a given year as established by the Mead Board of Education, unless the activity extends beyond the last official day of school. Consequences are accumulative for grades 7-8 and 9-12. The Activities Director, Principal, or designee shall make reasonable efforts to give parental notification prior to imposition of the suspension.

K. Exclusion/Expulsion from Co-Curricular Activities

Any student engaging in the prohibited conduct listed below, wherever or whenever such conduct occurs, will be ineligible for participation in co-curricular activities including practices for the remainder of the semester during which ineligibility is initially imposed and for the next semester. If the prohibited conduct occurs during the summer vacation period, the student will be ineligible to participate in co-curricular activities for the next school year. The disciplinary action prescribed by these rules may be in addition to disciplinary action permitted by any other policy or practice of the Mead Public Schools. The enforcement period for emergency Exclusion/Expulsion for the Co-Curricular Activity Regulation will relate to the calendar year.

L. Prohibited Conduct

1. Possession with intent to sell or distribute any illicit drug and/or controlled substance;
2. Selling or distributing any illicit drug and/or controlled substance;
3. Assault on a staff member;
4. Intentionally or knowingly causing serious bodily injury on any person;
5. Use or the attempted use of a weapon to injure another person;
6. Sexual assault on any person;
7. Felonious conduct deemed serious enough in nature to warrant emergency exclusion.

M. Counseling for Drug and Alcohol Use

(1) If the violation involves unlawful possession or use of illicit drugs, controlled substances or alcohol, a 1st time suspension can be reduced to a Level One Suspension if the student and his/her

parents/guardians agree that the student will undergo a drug and alcohol evaluation which could lead to drug and alcohol counseling.

(a) The counseling will continue until such time as all personnel involved agree that the counseling may cease. The student may begin participation while receiving counseling which the infractions committee approves.

(b) This counseling may extend beyond the evaluation and suspension period.

(c) All financial obligations incurred for this counseling will be the responsibility of the student and his/her parents/guardians.

(2) Should a student confide to the sponsor/coach of his/her respective activity, or any school staff member on his/her own free will and accord, and not in response to school staff learning of a rule violation or to the apparent likelihood that school staff will learn of a rule violation, that he/she has a problem with alcohol, drugs or any other chemical, no disciplinary action will be enacted for rule violations relating to that problem providing the student agrees to enter into a drug and alcohol evaluation which could lead to counseling. The student will continue the counseling until such time as all personnel involved agree that the counseling may cease. If counseling should cease prior to the specified time, a 3-week suspension from participating in events/contest of the co-curriculum will be enacted.

(b) All financial obligations incurred for the counseling will be the responsibility of the student and his/her parents/guardians.

(c) The student must confide in one of the above before the "fact", not after it is known by school personnel or the law enforcement agencies that he/she has been in violation of the school's activity policy.

N. Infractions Committee

The Activities Director may review any possible violation of the co-curricular activity regulation, which could lead to a suspension with an appointed Infractions Committee. This committee would consist of the building Principal, one teacher from the respective building, and one other uninvolved activity sponsor.

The Infractions Committee will determine as to whether or not the violations fall within the activity regulation guidelines and is serious enough to merit enactment. The Infractions Committee will determine the consequences. If the decision of the Infractions Committee is that the violation does not fall within the activity regulation guidelines or is not serious enough, the investigation stops immediately.

O. Staff Procedures

(A) Obtain from law enforcement officials information that identifies students who were cited or charged criminally or had petition filed in juvenile court against them for any of the reasons identified as prohibited conduct.

The Principal /AD will:

(B) Take action as required in these rules upon receipt of the information. The action must include:

1. Obtaining first-hand information regarding the citation and/or charge. This may include a contact with witnesses to the student's prohibited conduct.

2. If the building administration concludes the evidence supports the citation and/or charge, they must confer with the student to inform him/her of the charge and the available information, give the student an opportunity to tell his/her version of the incident, weigh the evidence as to the offense, make a decision whether the student engaged in the prohibited conduct and then inform the student of their decision.

3. Contact in writing will be made, and if possible, a verbal communication, informing the parent/guardian of the information and decision. The written notification must include notice of the citation and/or anticipated charge, the findings, the decision and how the student or parent may appeal the decision, if they choose. (See hearing procedure as outlined as part of the co-curricular activity policy.)

(C) The Superintendent of Schools will be informed of the action taken.

P. Hearing Procedure

Any student suspended or expelled from participation in the co-curricular activity program, may appeal

the suspension/expulsion the Violation Board. The appeal to the Violations Board (VB) shall not delay the effective time of the suspension or expulsion unless the (VB) agrees to such a delay.

The Principal/AD, Sponsor of the student in the co-curricular activities program, another Sponsor involved in the co-curricular activities programs, plus one teacher to be selected by the student shall constitute the (VB). If the violation involves a Jr. High student, the (VB) shall consist of Jr. High personnel in addition to the AD, if the violation involves a Sr. High student, the VB will consist of Sr. High personnel in addition to the AD.

The Principal/AD will assume the chairmanship of the (VB). Their duties as chairperson will include the setting of the date, time and place of the hearing and designating all personnel to serve on the (VB).

The (VB) shall meet within two days after the request for a hearing from the student and/or parents/guardians. The student and a parent/guardian shall be advised by telephone, in person, or in writing of the time, place, and purpose of the hearing. The hearing may be postponed at the request of the student for a reasonable time not to exceed two school days. The hearing shall be informal. The student may present witnesses in his/her behalf. The (VB) shall have the right to deliberate and reach its decision in closed meeting and shall have the right to limit the number and testimony of witnesses as necessary to preclude unreasonable repetitive or irrelevant testimony.

If the decision of the Violation Board is that a violation occurred, the head sponsor of the student will promptly visit with the student and a parent/guardian to state the decision and explain the discipline.

The student shall have the right to appeal the decision of the (VB) to the Superintendent of Schools. The appeal will be conducted within seven school days after receipt of the request. Such request for appeal shall not delay the effective time of the suspension or expulsion.

Should a question arise regarding a rule or regulation of the Nebraska School Activities Association and the need arises for an individual to know the due process procedures of the NSAA, they may be found in the NSAA yearbook which can be obtained from the Superintendent or Junior-Senior High Principal / AD.

Scope of the Code of Conduct.

Activities Subject to the Code of Conduct: The Code of Conduct applies to all extracurricular activities. Extracurricular activities means student activities or organizations which are supervised or administered by the school district which do not count toward graduation or grade advancement and in which participation is not otherwise required by the school.

Extracurricular activities include but are not limited to: all sports, cheerleading, dance team, Pep Club, Pep Band, vocal, band, speech and drama, One-Act, FBLA, FCCLA, FFA, Spanish Club, Art Club, Student Council, Student Advisory Board, National Honor Society, and other school sponsored organizations and activities. The Code of Conduct also affects a student's opportunity to serve as a candidate for Homecoming and Prom King or Queen, and also to be eligible for Athletic Royalty. A student who violates the Co-Curricular Policy prior to Homecoming will be ineligible to be a candidate for Homecoming King or Queen, but the student will be eligible for selection as a candidate for Prom King or Queen unless an additional violation occurs between Homecoming and Prom. A student who violates the Co-Curricular Policy after Homecoming but prior to Prom will be ineligible for selection as a candidate for Prom King or Queen. A student who violates the Co-Curricular Policy at any time in a given year will be ineligible for selection as Athletic Royalty.

Section 2 Sportsmanship at Athletic Events

Spectators should not:

1. No standing or running onto the floor or field during or after the games.
2. Use laser lights or artificial noisemakers.

3. Question the authority of the game officials or school supervisors.
4. Not heckle, jeer, or distract members or fans of the opposing team.
5. Bring any outside liquids to the games.
6. Never criticize the players or coaches for the loss of a game.
7. Use vulgar or obscene language or gestures.
8. Only credentialed media, Mead Public School's yearbook/journalism photographers, and contracted photographers will be allowed in "restricted" areas of games.

School officials reserve the right to remove any students or adults from the premises who conduct themselves in a manner inconsistent with the above expectations. Officials also reserve the right to exempt students and adults from future school activities.

Section 3 School Dances

A school sponsored dance is a school activity subject to all provisions of the Student Activity Code, and is a privilege available to students meeting all requirements for participation. Breathalyzers are generally administered to all students who attend school dances. The following guidelines apply to dances:

- 1) Dances and other activities will be supervised by school staff members.
- 2) Once students enter the activity, they are not to leave unless leaving for the evening.
- 3) Dances are generally open only to Mead High school Students and their guests. When dances are open to non-senior high students, guests may be required to be pre-registered and are subject to the same rules as students. No one 21 years of age or older will be allowed to attend school dances
- 4) Students who are excluded from a school activity for behavior may also be excluded from future activities.
- 5) Violation of any of the above rules may result in suspension from school and from attending or participating in other school activities.
- 6) Students who have been suspended (out-of-school) from school or from extracurricular activities will not be permitted to attend.
- 7) Students and their guests must meet the dress code requirements established for each dance. Teachers or administrators will make the final decision as to whether or not a student's attire is appropriate. Students will be asked to change unacceptable items, which may mean that the student may have to return home to change the inappropriate clothing. It is advisable to check in advance of the dance with the Principal or staff sponsor for the event if are uncertain about attire.

Section 4 Student Fees Policy

The Board of Education of the Mead Public Schools adopts the following student fees policy in accordance with the Public Elementary and Secondary Student Fee Authorization Act.

The District's general policy is to provide for the free instruction in school in accordance with the Nebraska Constitution and state and federal law. This generally means that the District's policy is to provide free instruction for courses which are required by state law or regulation and to provide the staff, facility, equipment, and materials necessary for such instruction, without charge or fee to the students.

The District does provide activities, programs, and services to children, which extend beyond the minimum level of constitutionally required free instruction. Students and their parents have historically contributed to the District's efforts to provide such activities, programs, and services-The District's general policy is to continue to encourage and to the extent permitted by law, to require such student and parent

contributions to enhance the educational program provided by the District.

Under the Public Elementary and Secondary Student Fee Authorization Act, the District is required to set forth in a policy its guidelines or policies for specific categories of student fees. The District does so by setting forth the following guidelines and policies. This policy is subject to further interpretation or guidance by administrative or Board regulations, which may be adopted from time to time. The Policy includes Appendix “1” which provides further specifics of student fees and materials required of students for the 2026-2027 school year. Parents, guardians, and students are encouraged to contact their building administration or their teachers or activity coaches and sponsors for further specifics.

Section 5 Senior Sneak

Senior Sneak is a day trip for senior class members that are on track to graduate on time. Seniors that do not earn the necessary credits to graduate by the deadline established by the administration will not be eligible to attend Senior Sneak. Because Senior Sneak is a school sponsored event, no student-organized skip days will be allowed. Students believed to have participated in such skip days will not be eligible for Senior Sneak.

Article 9 - State and Federal Programs

Section 1 Notice of Nondiscrimination

The Mead Public Schools does not discriminate on the basis of sex, disability, race, color, religion, military or veteran status, national or ethnic origin, marital status, pregnancy, childbirth or related medical condition, or other protected status in its programs and activities and provides equal access to the Boy Scouts and other designated youth groups. Reasonable accommodations will be provided to employees with disabilities and to those who are pregnant, have given birth, or have a related medical condition, as required by law. Section 3 Anti-discrimination & Harassment Policy

Elimination of Discrimination. The Mead Public Schools hereby gives this statement of compliance and intends to comply with all state and federal laws prohibiting discrimination. This school district intends to take any necessary measures to assure compliance with such laws against any prohibited form of discrimination. For more information regarding the elimination of discrimination, harassment, and anti-retaliation, please consult policies 4003 and 5401/

Article 9 – State and Federal Programs

Preventing Harassment and Discrimination of Students.

Purpose: The Mead Public Schools is committed to offering employment and educational opportunities to its employees and students in a climate free of discrimination. Accordingly, unlawful discrimination, harassment or retaliation of any kind by District employees, including, co-workers, non-employees (such as volunteers), third parties, and others is strictly prohibited and will not be tolerated.

Harassment is a form of discrimination and includes verbal, non-verbal, written, graphic, or physical conduct relating to a person's sex, disability, race, color, religion, military or veteran status, national or ethnic origin, age, marital status, pregnancy, childbirth or related medical condition, or other protected status, that is sufficiently serious to deny, interfere with, or limit a person's ability to participate in or benefit from an educational or work program or activity, including, but not limited to:

- a. Conduct that is sufficiently severe or pervasive to create an intimidating, hostile, or abusive educational or work environment, or
- b. Requiring an individual to endure the offensive conduct as a condition of continued employment or educational programs or activities, including the receipt of aids, benefits, and services.

Educational programs and activities include all academic, educational, extracurricular, athletic, and other programs of the school, whether those programs take place in a school's facilities, on a school bus, at a class or training program sponsored by the school at another location, or elsewhere.

Discriminatory harassment because of a person's sex, disability, race, color, religion, military or veteran status, national or ethnic origin, age, marital status, pregnancy, childbirth or related medical condition, or other protected status, may include, but is not limited to:

- a. Name-calling,
- b. Teasing or taunting,
- c. Insults, slurs, or derogatory names or remarks,
- d. Demeaning jokes,
- e. Inappropriate gestures,
- f. Graffiti or inappropriate written or electronic material,
- g. Visual displays, such as cartoons, posters, or electronic images,
- h. Threats or intimidating or hostile conduct,
- i. Physical acts of aggression, assault, or violence, or
- j. Criminal offenses

The following examples are additional or more specific examples of conduct that may constitute sexual harassment:

- a. Unwelcome sexual advances or propositions,
- b. Requests or pressure for sexual favors,
- c. Comments about an individual's body, sexual activity, or sexual attractiveness,
- d. Physical contact or touching of a sexual nature, including touching intimate body parts and inappropriate patting, pinching, rubbing, or brushing against another's body,
- e. Physical sexual acts of aggression, assault, or violence, including criminal offenses (such as rape, sexual assault or battery, and sexually motivated stalking), against a person's will or where a person is incapable of giving consent due to the victim's age, intellectual disability, or use of drugs or alcohol,
- f. Requiring sexual favors or contact in exchange for aids, benefits, or services, such as grades, awards, privileges, promotions, etc., or
- g. Gender-based harassment; acts of verbal, nonverbal, written, graphic, or physical conduct based

on sex or sex-stereotyping, but not involving conduct of a sexual nature.

If the District knows or reasonably should know about possible harassment, including violence, the District will conduct a prompt, adequate, reliable, thorough, and impartial investigation to determine whether unlawful harassment occurred (see section entitled “Grievance Procedures,” below), and take appropriate interim measures, if necessary. If the District determines that unlawful harassment occurred, the District will take prompt and effective action to eliminate the harassment, prevent its recurrence, and remedy its effects, if appropriate. If harassment or violence that occurs off school property creates a hostile environment at school, the District will follow this policy and grievance procedure, within the scope of its authority.

All District employees are expected to take prompt and appropriate actions to report and prevent discrimination, harassment, and retaliation by others. Employees who witness or become aware of possible discrimination, including harassment and retaliation, must immediately report the conduct to his or her supervisor or the compliance coordinator designated to handle complaints of discrimination (designated compliance coordinator).

Anti-retaliation

The District prohibits retaliation, intimidation, threats, coercion, or discrimination against any person for opposing discrimination, including harassment, or for participating in the District's discrimination complaint process or making a complaint, testifying, assisting, or participating in any manner, in an investigation, proceeding, or hearing. Retaliation is a form of discrimination.

The District will take immediate steps to stop retaliation and prevent its recurrence against the alleged victim and any person associated with the alleged victim. These steps will include, but are not limited to, notifying students, employees, and others, that they are protected from retaliation, ensuring that they know how to report future complaints, and initiating follow-up contact with the complainant to determine if any additional acts of discrimination, harassment, or retaliation have occurred. If retaliation occurs, the District will take prompt and strong responsive action, including possible discipline, including expulsion or termination, if applicable.

Grievance (or Complaint) Procedures

Employees or students should initially report all instances of discrimination, harassment or retaliation to their immediate supervisor or teacher or to the compliance coordinator designated to handle complaints of discrimination. If the employee or student is uncomfortable in presenting the problem to the supervisor or teacher, or if the supervisor or teacher is the problem, the employee or student may report the alleged discrimination, harassment or retaliation to the designated coordinator, or in the case of students, to another staff person (such as a counselor or principal).

Other individuals may report alleged discrimination to the designated coordinator. If the designated coordinator is the person alleged to have committed the discriminatory act, then the complaint should be submitted to the Superintendent for assignment. A discrimination complaint form is available in the office of each District building, on the District's website, and from the designated coordinators. Under no circumstances will a person filing a complaint or grievance involving discrimination be retaliated against for filing the complaint or grievance.

Section 4 Dating Violence Policy

Mead Public Schools strives to provide physically safe and emotionally secure environments for all

students and staff. Positive behaviors are encouraged in the educational program and are required of all students and staff. Dating violence will not be tolerated. For purposes of this policy “dating violence” means a pattern of behavior where one person uses threats of, or actually uses, physical, sexual, verbal, or emotional abuse to control his or her dating partner. “Dating partner” means any person, regardless of gender, involved in an intimate relationship with another person primarily characterized by the expectation of affectionate involvement whether casual, serious, or long term.

Incidents of dating violence involving students at school will be addressed as the administration determines appropriate, within the scope and subject to the limits of the District’s authority. Staff training on dating violence shall be provided as deemed appropriate by the administration. The dating violence training shall include, but need not be limited to, basic awareness of dating violence, warning signs of dating violence, and the District’s dating violence policy.

Dating violence education that is age-appropriate shall be incorporated into the school program. Dating violence education shall include, but not be limited to, defining dating violence, recognizing dating violence warning signs, and identifying characteristics of healthy dating relationships. The administration will be responsible for ensuring that this dating violence policy is published in the school district’s student-parent handbook or an equivalent such publication. Parents and legal guardians shall be informed of the dating violence policy by such other means as the administration determines appropriate. If requested, parents or legal guardians shall be provided a copy of the dating violence policy and relevant information.

Section 5 Multicultural Policy

The philosophy of the District’s multicultural education program is that students will have improved ability to function as productive members of society when provided with: (a) an understanding of diverse cultures and races, the manner in which the existence of diverse cultures and races have affected the history of our Nation and the world, and of the contributions made by diverse cultures and races (including but not be limited to African Americans, Hispanic Americans, Native Americans, Asian Americans and European Americans) and (b) with the ability and skills to be sensitive toward and to study, work and live successively with persons of diverse cultures and races. The mission shall also include preparing students to eliminate stereotypes and discrimination or harassment of others based on ethnicity, religion, gender, socioeconomic status, age, or disability.

Section 6 Notice to Parents of Rights Afforded by Section 504 of the Rehabilitation Act of 1973

The following is a description of the rights granted to qualifying students with disabilities under Section 504 of the Rehabilitation Act. The intent of the law is to keep you fully informed concerning the decisions about your child and to inform you of your rights if you disagree with any of these decisions. You have the right to:

1. Have your child take part in, and receive benefits from, public education programs without discrimination because of his/her disability.
2. Have the school district advise you of your rights under federal law.
3. Receive notice with respect to identification, evaluation or placement of your child.
4. Have your child receive a free appropriate public education.
5. Have your child receive services and be educated in facilities which are comparable to those provided to every student.
6. Have evaluation, educational and placement decisions made based on a variety of information sources and by persons who know the student and who are knowledgeable about the evaluation data and placement options.

7. Have transportation provided to and from an alternative placement setting (if the setting is a program not operated by the district) at no greater cost to you than would be incurred if the student were placed in a program operated by the district.
8. Have your child be given an equal opportunity to participate in nonacademic and extracurricular activities offered by the district.
9. Examine all relevant records relating to decisions regarding your child's identification, evaluation and placement.
10. Request mediation or an impartial due process hearing related to decisions or actions regarding your child's identification, evaluation, educational program or placement. (You and your child may take part in the hearing. Hearing requests are to be made to the Superintendent).
11. File a local grievance.

Section 7 Notification of Rights Under FERPA

The Family Educational Rights and Privacy Act (FERPA) affords parents and students over 18 years of age ("eligible students") certain rights with respect to the student's education records. They are:

1. The right to inspect and review the student's education records within 45 days of the day the district receives a request for access. Parents or eligible students should submit to the school principal (or appropriate school official) a written request that identifies the record(s) they wish to inspect. The principal will make arrangements for access and notify the parent or eligible student of the time and place where the records may be inspected.
2. The right to request the amendment of the student's education records that the parent or eligible student believes are inaccurate or misleading at the time the record was created. Parents or eligible students may ask the school district to amend a record that they believe is inaccurate or misleading. They should write the school principal, clearly identify the part of the record they want changed, and specify why it is inaccurate or misleading. If the district decides not to amend the record as requested by the parent or eligible student, the district will notify the parent or eligible student of the decision and advise them of their right to a hearing regarding the request for amendment. Additional information regarding the hearing procedures will be provided to the parent or eligible student when notified of the right to a hearing.
3. The right to consent to disclosures of personally identifiable information contained in the student's education records, except to the extent that FERPA authorizes disclosure without consent. One exception which permits disclosure without consent is disclosure to school officials with legitimate educational interests or otherwise allowed by law. A school official is a person employed by the district as an administrator, supervisor, instructor or support staff member (including health or medical staff and law enforcement unit personnel); a person serving on the school board; a person or company with whom the District has contracted to perform a special task (such as an attorney, auditor, medical consultant or therapist); or a parent or student serving on an official committee, such as a disciplinary or grievance committee or assisting another school official in performing his or her tasks. A school official has a legitimate educational interest if the official needs to review an education record in order to fulfill his or her professional responsibility and effectively provide the function or service for which they are responsible.

The District forwards education records (may include academic, health and discipline

records) to schools that have requested the records and in which the student seeks or intends to enroll, or where the student has already enrolled so long as the disclosure is for purposes related to the student’s enrollment or transfer.

4. The right to file a complaint with the U.S. Department of Education concerning alleged failures by the district to comply with the requirements of FERPA. The name and address of the office that administers FERPA is:

NOTICE CONCERNING DIRECTORY INFORMATION

The District may disclose directory information. The types of personally identifiable information that the district has designated as directory information are as follows: student’s name, address, telephone number, electronic mail address, photograph, , dates of attendance, grade level, enrollment status (e.g., full-time or part-time), participation in officially recognized activities and sports, weight and height of members of athletic teams, degrees, honors and awards received. A parent or eligible student has the right to refuse to let the District designate any or all of those types of information about the student as directory information. Parents or guardians may refuse to allow their student’s information be designated as “directory information” at any time during the school year, so long as the parent or guardian notifies the Superintendent in writing.

Section 8 Notice Concerning Disclosure of Student Recruiting Information

The Every Student Succeeds Act requires that the District provide military recruiters and institutions of higher education access to secondary school students’ names, addresses, and telephone listings. Parents and secondary students have the right to request that the District not provide this information (i.e., not provide the student’s name, address, and telephone listing) to military recruiters or institutions of higher education, without their prior written parental consent. The District will comply with any such request.

Section 9 Notice Concerning Parents Right to Know, Staff Qualifications, and Testing Opt-Out

At the beginning of each school year, if the District receives Title I funding, the District shall notify the parents of each student attending any school receiving Title I funds that the parents may request, and the District will provide the parents on request (and in a timely manner), information regarding the professional qualifications of the student’s classroom teachers, including at a minimum, whether the students teacher:

1. has met State qualification and licensing criteria for the grade levels and subject areas in which the teacher provides instruction;
2. is teaching under emergency or other provisional status through which State qualification or licensing criteria have been waived; and
3. is teaching in the field of discipline of the certification of the teacher.

We will also inform parents on request whether the child is provided services by paraprofessionals and, if so, their qualifications.

At the beginning of each school year, if the District receives Title I funding, the District shall notify the parents of each student attending any school receiving Title I funds that the parents may request, and the District will provide the parents on request (and in a timely manner), information regarding any State or

District policy regarding student participation in any State or District assessments, including the District's policy and procedure on the parental right to opt the child out of such assessment(s). The District shall also make widely available through public means (including by posting in a clear and easily accessible manner on the District's website) information on each State or District assessment, including:

- (A) the subject matter assessed;
- (B) the purpose for which the assessment is designed and used;
- (C) the source of the requirement for the assessment;
- (D) the amount of time students will spend taking the assessment, and the schedule for the assessment; and
- (E) the time and format for disseminating results.

Section 10 Student Privacy Protection Policy

It is the policy of Mead Public Schools to develop and implement policies which protect the privacy of students in accordance with applicable laws. Parents shall have the right to inspect surveys administered to their students, and parents have the right to opt-out of surveys containing matters deemed to be sensitive.

Right of Parents to Inspect Instructional Materials: Parents have the right to inspect, upon reasonable request, any instructional material used as part of the educational curriculum for their child. Reasonable requests for inspection of instructional materials shall be granted within a reasonable period of time after the request is received. Parents shall not have the right to access academic tests or academic assessments, as such are not within the meaning of the term "instructional materials" for purposes of this policy. The procedures for making and granting a request to inspect instructional materials are as follows: the parent shall make the request, with reasonable specificity, directly to the building principal. The building principal, within five (5) school days, shall consult with the teacher or other educator responsible for the curriculum materials. In the event the request can be accommodated, the building principal shall make the materials available for inspection or review by the parent, at such reasonable times and place as will not interfere with the educator's intended use of the materials. In the event there is a question as to the nature of the curriculum materials requested or as to whether the materials are required to be provided, the building principal shall notify the parent of such concern, and assist the parent with forming a request which can reasonably be accommodated. If the parent does not formulate such a request, and continues to desire certain curriculum materials, the parent shall be asked to make their request to the Superintendent.

Rights of Parents to be Notified of and to Opt-Out of Certain Physical Examinations or Screenings. The general policy and practice of the District is to not administer physical examinations or screenings of students which require advance notice or parental opt-out rights under the applicable federal laws, for the reason that the physical examinations or screenings to be conducted by the District will usually fit into one of the following exceptions: (1) hearing, vision, or scoliosis screenings; (2) physical examinations or screenings that are permitted or required by an applicable State law; and (3) surveys administered to students in accordance with the Individuals with Disabilities Education Act. For physical examinations or screenings which do not fit into the applicable exceptions, the District will follow the procedures set forth in the section entitled: "Notification of and Right to Opt-Out of Specific Events."

Protection of Student Privacy in Regard to Personal Information Collected from Students: The general policy and practice of the District is to not engage in the collection, disclosure, or use of personal information collected from students for the purpose of marketing or for selling that information. The District will make reasonable arrangements to protect student privacy to the extent possible in the event

of any such collection, disclosure, or use of personal information. “Personal information” for purposes of this policy means individually identifiable information about a student including: a student or parent’s first and last name, home address, telephone number, and social security number. The term “personal information,” for purposes of this policy, does not include information collected from students for the exclusive purpose of developing, evaluating, or providing educational products or services for, or to, students or educational institutions. This exception includes the following examples: (i) college or postsecondary education recruitment, or military recruitment; (ii) book clubs, magazines, and programs providing access to low-cost literary products; (iii) curriculum and instructional materials used by elementary schools and secondary schools; (iv) tests and assessments used by elementary schools and secondary schools to provide cognitive, evaluative, diagnostic, clinical, aptitude, or achievement information about student, or to generate other statistically useful data for the purpose of securing such tests and assessments, and the subsequent analysis and public release of the aggregate data from such tests and assessments; (v) the sale by student of products or services to raise funds for school-related or education-related activities; (vi) student recognition programs.

Parental Access to Instruments used in the Collection of Personal Information: While the general practice of the District is to not engage in the collection, disclosure, or use of personal information collected from students for the purpose of marketing or for selling that information, parents shall have the right to inspect, upon reasonable request, any instrument which may be administered or distributed to a student for such purposes. Reasonable requests for inspection shall be granted within a reasonable period of time after the request is received. The procedures for making and granting such a request are as follows: the parent shall make the request, with reasonable specificity, directly to the building principal and shall identify the specific act and the school staff member or program responsible for the collection, disclosure, or use of personal information from students for the purpose of marketing that information. The building principal, within five (5) school days, shall consult with the school staff member or person responsible for the program which has been reported by the parent to be responsible for the collection, disclosure, or use of personal information from students. In the event such collection, disclosure, or use of personal information is occurring or there is a plan for such to occur, the building principal shall consult with the Superintendent for determination of whether the action shall be allowed to continue. If not, the instrument for the collection of personal information shall not be given to any students. If it is to be allowed, such instrument shall be provided to the requesting parent as soon as such instrument can be reasonably obtained.

Annual Parental Notification of Student Privacy Protection Policy: The District provides parents with reasonable notice of the adoption or continued use of this policy and other policies related to student privacy. Such notice shall be given to parents of students enrolled in the District at least annually, at the beginning of the school year, and within a reasonable period of time after any substantive change in such policies.

Notification to Parents of Dates of and Right to Opt-Out of Specific Events: The District will directly notify the parents of the affected children, at least annually at the beginning of the school year, of the specific or approximate dates during the school year when any of the following activities are scheduled, or are expected to be scheduled:

The collection, disclosure, or use of personal information collected from students for the purpose of marketing or for selling that information. (Note: the general practice of the District is to not engage in the collection, disclosure, or use of personal information collected from students for the purpose of marketing or for selling that information). Surveys of students involving

one or more matters deemed to be sensitive in accordance with the law and this policy; and, any non-emergency, invasive physical examination or screening that is required as a condition of attendance; administered by the school and scheduled by the school in advance; and not necessary to protect the immediate health and safety of the student or of other students. (Note: the general practice of the District is to not engage in physical examinations or screenings which require advance notice, for the reason that the physical examinations or screenings to be conducted by the District will usually fit into one of the following exceptions to the advance notice requirement and parental opt-out right: (1) hearing, vision, or scoliosis screenings; (2) physical examinations or screenings that are permitted or required by an applicable State law, and (3) surveys administered to students in accordance with the Individuals with Disabilities Education Act).

Parents shall be offered an opportunity in advance to opt their child out of participation in any of the above listed activities. In the case of a student of an appropriate age (that is, a student who has reached the age of 18, or a legally emancipated student), the notice and opt-out right shall belong to the student.

Definition of Surveys of Matters Deemed to be Sensitive: Any survey containing one or more of the following matters shall be deemed to be “sensitive” for purposes of this policy:

1. Political affiliations or beliefs of the student or the student’s parent;
2. Mental or psychological problems of the student or the student’s parent;
3. Sex behavior or attitudes;
4. Illegal, anti-social, self-incriminating or demeaning behavior;
5. Critical appraisals of other individuals with whom the student has close family relationships;
6. Legally recognized privileged or analogous relationships, such as those of lawyers, physicians, and ministers;
7. Religious practices, affiliations, or beliefs of the students or the student’s parent;
8. Income (other than that required by law to determine eligibility for participation in a program or for receiving financial assistance under such program).

Section 11 Parental Involvement Policies

Mead Public Schools welcomes parental involvement in the education of their children. We recognize that parental involvement increases student success. It is the District’s policy to foster and facilitate, to the extent appropriate and in their primary language, parental information about, and involvement in, the education of their children. Policies and regulations are established to protect the emotional, physical and social well-being of all students.

On occasion, the school staff may invite parents to assist with sponsorship of students at school events such as field trips, room parties, etc. Such participation shall be by invitation of the teacher and/or building principal.

School Library Materials and Parent Access: Pursuant to policy 5209, parents/guardians wishing to receive notification of library books checked out to their child will contact a building administrator in writing to request this information. The administrator will communicate such requests to the librarian for setup. Upon opting in, parents/guardians will be notified via email as to the author, title, and due date of the books checked out by their student(s).
