

A Regular Meeting of the Board of Education, District 72, Mead, Nebraska, was held Monday, February 8, 2021 in the Jr.-Sr. High School commons. President Mongan called the meeting to order at 7:00 p.m. The following board members were present: Kevin Hough, Janeen Felty, Nate Mongan, Stephanie Langemeier, Sara Nicola and Brenda Halbmaier.

Visitors addressed the board about including mask choice in the school's Covid plan.

Superintendent Quinn reported on bids for the gymnasium/weight room project.

President Mongan appointed the following committees, Americanism: Hough, Halbmaier, Felty; Negotiations: Langemeier, Mongan, Nicola; Paulson Scholarship: Felty; Wageman Scholarship: Hough.

The following other action was taken by unanimous vote: approval of the Minutes, Bills and Financial report; approval of the Consent agenda; accept Rogge Construction's bid of \$4,558,000, which includes the alternate precast concrete panel supplier, and enter into a construction contract with Rogge Construction with a start date of March 15, 2021 and substantial completion within 320 days. Recess into closed session at 8:37 pm, for the prevention of needless injury to the reputation of an individual with recognition that such individual has not requested a public meeting with the purpose of discussing the evaluation of the job performance of the superintendent pursuant to the provisions of Nebraska Statute 84-1410 out of closed session at 9:06 pm.
